Description of the Planned Network Change(s):

The Hawaiian Telcom Puunui GTD5 remote switch (PNUIHICORS1), located at 415 Wyllie St, Honolulu, HI 96817, will be rehomed from the Honolulu GTD5 switch (HNLLHIMNDS1) to the Kaimuki GTD5 switch (KAIMHICODS1), located at 1103 9th Ave due to the pending decommissioning of the Honolulu GTD5 switch (HNLLHIMNDS1). Network trunks will be interconnected through the Kaimuki GTD5 switch (KAIMHICODS1) to access customers on the Puunui GTD5 remote switch (PNUIHICORS1). Once these changes are completed, the host switch for Puunui will be changed to the Kaimuki GTD5 switch (KAIMHICODS1) and reflected in the LERG. Traffic to be migrated through the Kaimuki GTD5 switch (KAIMHICODS1) includes, but is not limited to, Inter-LATA access traffic (including Feature Group B and D traffic), Intra-LATA traffic, and local traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Independent LECs, Wireless Service Providers, CLECs and Interexchange Carriers interconnection arrangements for traffic currently originating from and terminating to the PNUIHICORS1 end office switch will be affected by the planned network change. Direct interconnection for the exchange of voice traffic originating from and terminating to customers served by the PNUIHICORS1 end office switch will occur at the KAIMHICODS1 end office host switch. The Point Code for PNUIHICORS1 will be 002-102-009, which is the KAIMHICODS1 Point Code. Independent LECs, Wireless Service Providers, CLECs, and Interexchange Carriers must evaluate whether their existing trunk groups to KAIMHICODS1 are adequate to handle the PNUIHICORS1 traffic after the migration is completed.

All ASRs for the Kaimuki GTD5 switch (KAIMHIMNDS1) for trunk interconnection must include the project code of HNLLHIMNDS1. All carriers (e.g., CLEC, Wireless or IEC) should submit direct end office trunk (DEOT) orders no later than 8/24/2017. These DEOT interconnections will support traffic migration for the Puunui rehome. Prior to rehome of the Puunui GTD5 remote switch (PNUIHICORS1), on or after 9/14/2017, LERG change effective dates will be posted. This will serve to guide interconnect re-routes of traffic for the 2 (two) native codes currently served by the Puunui GTD5 switch (PNUIHICORS1) to reflect the Kaimuki GTD5 switch (KAIMHICODS1) as the new host switch.

Description of the Planned Network Change(s):

The Hawaiian Telecom Honolulu GTD5 switch (HNLLHIMNDS1), located at 1177 Bishop St, Honolulu, HI 96813, will be decommissioned and replaced by the Hawaiian Telecom Honolulu DMS100 switch (HNLLHIMNDS2), located at 1177 Bishop St, Honolulu, HI 96813. After all traffic served by the Honolulu GTD5 switch (HNLLHIMNDS1) is migrated to the Honolulu DMS100 switch (HNLLHIMNDS2), the Honolulu GTD5 switch (HNLLHIMNDS1) will be decommissioned (retired). Network trunks will be interconnected through the Honolulu DMS100 switch (HNLLHIMNDS2). Once these changes are completed, the Honolulu DMS100 switch (HNLLHIMNDS2) for all twelve (12) NPA NXX codes that are currently native to the Honolulu GTD5 switch (HNLLHIMNDS1) will be reflected in the LERG. Traffic to be migrated to the Honolulu DMS100 switch (HNLLHIMNDS2) includes, but is not limited to, Inter-LATA access traffic (including Feature Group B and D traffic), Intra-LATA traffic, and local traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Independent LECs, Wireless Service Providers, CLECs and Interexchange Carriers interconnection arrangements for traffic currently originating from and terminating to the HNLLHIMNDS1 end office switch will be affected by the planned network change. Direct interconnection for the exchange of voice traffic originating from and terminating to customers currently served by the HNLLHIMNDS1 end office host switch will now occur at the HNLLHIMNDS2 end office host switch. The Point Code for HNLLHIMNDS2 is 002-102-106. All existing trunking to HNLLHIMNDS1 will be eliminated. Independent LECs, Wireless Service Providers, CLECs, and Interexchange Carriers must evaluate whether their existing trunk groups to HNLLHIMNDS2 are adequate to handle the additional traffic after the migration is completed.

All ASRs for the Honolulu DMS100 switch (HNLLHIMNDS2) for trunk interconnection must include the project code of HNLLHIMNDS1. All carriers (e.g., CLEC, Wireless or IEC) should submit direct end office trunk (DEOT) orders no later than 11/16/2017. These DEOT interconnections will support traffic migration for the Honolulu GTD5 switch (HNLLHIMNDS1) prior to its eventual decommissioning. Prior to decommissioning of the Honolulu GTD5 switch (HNLLHIMNDS1), on or after 12/14/2017, LERG change effective dates will be posted. This will serve to guide interconnect re-routes of traffic for the 12 (twelve) native codes currently served by the Honolulu GTD5 switch (HNLLHIMNDS1) to reflect the Honolulu DMS100 switch (HNLLHIMNDS1) as the new home switch.
