On July 9, 2019, the following representatives of The Walt Disney Company, ABC, and the ABC Owned Television Stations had a series of meetings at the FCC:

Wendy McMahon, President, ABC Owned Television Stations  
John Rouse, EVP, ABC Affiliate Relations and Marketing  
Richard Bates, SVP, Government Relations, The Walt Disney Company.<sup>1</sup>  
Susan Fox, VP, Government Relations, The Walt Disney Company

The Disney/ABC executives met with the following FCC officials: (1) Commissioner Michael O'Rielly, Joel Miller and Christopher McGillen; (2) Commissioner Brendan Carr and Evan Swarztrauber; (3) Commissioner Jessica Rosenworcel; (4) Matthew Berry (Chief of Staff); and (5) Commissioner Geoffrey Starks and Michael Scurato.

During these meetings, Ms. McMahon discussed recent innovations by the ABC Owned Television Stations, including the launch of ABC's Localish, a new digital brand that brings out the good in America's cities through locally sourced, yet nationally relevant stories. She also described the Owned Stations' recently-launched Community Journalism program, consisting of reporters embedded in local communities to uniquely inform and reflect their local audiences. Mr. Rouse discussed the importance of ABC's expansion in select local markets through affiliations with local stations that carry ABC network programming (together with local news) on one of their multicast channels. Mr. Rouse also updated the FCC officials on continued increases in distribution of ABC owned as well as affiliated stations by over-the-top video

distributors. Ms. Fox noted Disney's previously-stated position that there is no need for the FCC to expand the FCC's current definition of MVPDs.
