RESPONSE: Consistent with and without waiving its June 26, 2019 Objections, please see Exhibit A to this Response.


INTERROGATORY NO. 10:

RESPONSE: Consistent with and without waiving its June 26, 2019 Objections, ComEd has yet to issue its 2019 invoices for pole attachment rental, but otherwise Sunesys, Lightower, and Crown Castle NG Central have paid ComEd's annual pole attachment rental invoices in full. As explained in ComEd's Answer, however, ComEd is confused about the relationship between Crown Castle and Sunesys, Lightower, and Crown Castle NG Central.
