

Curtis J. Neeley Jr. Reply to 153,778 repetitive and almost certainly “*astroturf*” comments

The search for “[obama-era fcc](#)” resulted in 112,500 results on 8/03/2017 and each of these “brief” comments read exactly as follows:

“The Obama-era FCC regulations known as "Title II" enable the federal government to exert an extraordinary and unnecessary amount of regulatory control over the internet. This bureaucratic overreach impedes innovation, stifles investment and continues to create economic uncertainty for one of the largest sectors of the U.S. economy. I support Chairman Pai's proposal to roll back Title II and restore the sensible regulatory framework that enjoyed broad bipartisan consensus and enabled the internet to thrive for more than two decades. I strongly urge all of the FCC Commissioners to support the Chairman's proposal to repeal the harmful Title II internet takeover.

Further examination of the public record looking for those calling Title II a “[Depression-era](#)” regulation found 141,278 comments on 8-3-2017. These are not nearly consistent enough to be dismissed wholly as “*astroturfing*” like follows though this general format was followed very closely:

The FCC's Open Internet Rules (net neutrality rules) are extremely unconstitutional and detrimental to technological innovation. I urge you to abolish them. The Depression-era regulatory authority the FCC is trying to reach for is unfounded by existing statute, and the statute which does exist is in opposition to the U.S. Constitution.
