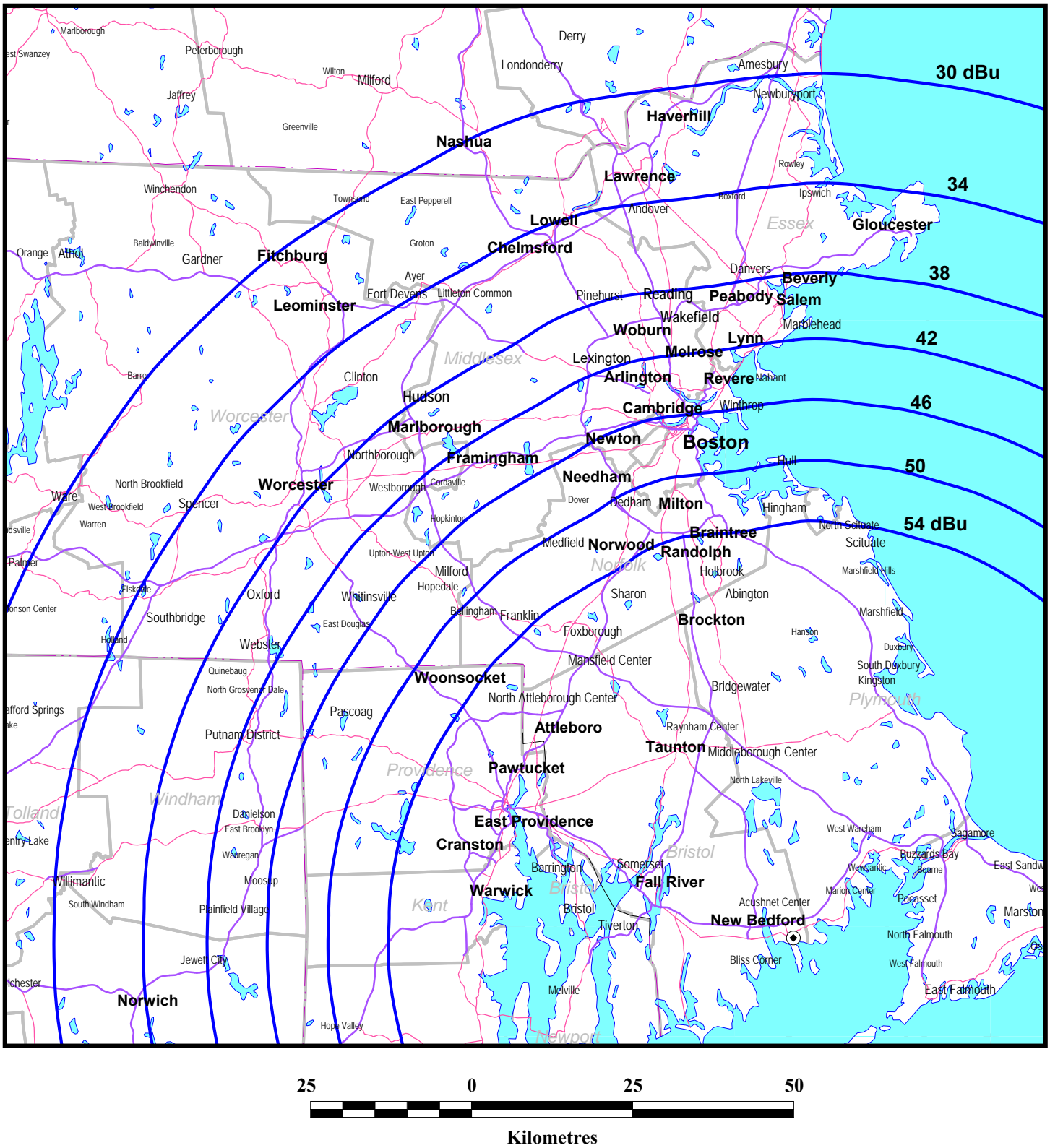

I am writing to you regarding the Commission's proposed modification of Section 74.1203(a)(3) that apparently would adversely affect many listeners of **WJFD (the Portuguese Radio)** who have relied upon **WJFD's uniquely important broadcasts for over 35 years**.

Being the Portuguese General Consul in Boston, I am addressing this matter to you in my institutional and professional capacity witnessing the importance of this truly **Portuguese Radio** of the significant Portuguese Community, Portuguese-American Community, and the Portuguese Speaking Communities of the larger New England region

But I also gladly make those comments on the basis of my personal knowledge from listening WJFD on a regular and personal daily basis, making many trips from Newton to Boston, the Cambridge and Somerville area and all over Massachusetts while listening to WJFD.

WJFD is located in the Southcoast area of Massachusetts, where there is a well known significant presence of Portuguese residents, namely in the New Bedford, Fall River and Taunton areas.

Nevertheless, WJFD has also for many years right up until today long reached Portuguese Communities in the Worcester, Boston, Cambridge, Somerville, Peabody, and Lowell areas.

Large numbers of Portuguese, who were part of a wave of immigration during the 60's, 70's, and 80's, also settled in the Boston, Cambridge, Somerville, Hudson, Worcester, Salem-Gloucester, Lowell, and Peabody areas (well outside the more traditional areas of the Portuguese communities in the South of Massachusetts) and also to nearby cities and towns like Medford, Woburn, Billerica, Wilmington, Malden, Everett, Chelsea, Revere, and Lynn.

WJFD brings daily news from mainland Portugal, the Azores (and also from Cape Verde, and Brazil among other Portuguese Speaking countries worldwide) as well as specific and useful news from the New England area, informing well those communities, in all sort of social, commercial, political, and cultural dimensions.

It also broadcasts sports, Portuguese soccer games with very popular broadcast programs and faithful listeners mostly in the Boston, Lowell and Peabody areas.

WJFD truly brings to those communities at large uniquely Portuguese events far beyond and outside the origin of the geographical location of the radio itself. All those Portuguese communities have predominantly indeed come to rely on WJFD, for more than three decades, as an important and unique link to Portugal, including the Azores, and their vibrant language and culture. Also for many elder people who are retired or who are widowed WJFD provides great companionship and emotional support, offering a dimension of wellbeing public.

If any radio station is to be classified as a **"community" radio station**, then, **WJFD is truly the one.**

This is why I have been genuinely approached by so many Portuguese People of this particular consular region of the Boston Portuguese General Consulate really concerned and afraid that they could lose all of that by loosing this WJFD radio community, particularly those outside of the Massachusetts South Coast, apparently the most affected by the proposed rule which will prove to be especially unfair and devastating for them.

The possibility of losing WJFD and no longer being able to pursue their daily routine to listen to their only community radio will certainly be devastating to the Portuguese Community here with terrible consequences by not contributing to the desirable and rich cultural and ethnicity diversity of this great region.

There is no Portuguese radio or Portuguese Language radio similar to **WJFD** in this region.

For the foregoing reasons, I only heard Portuguese Community members, for whom I care and to whom I listen, taking in due consideration their concerns, truly worried, and requesting that the Commission do not adopt the proposed modification to Section 74.1203(a)(3) *"to state that no complaint of actual interference will be considered actionable if the alleged interference occurs outside the desired station's 54 dBu contour."*

Certainly that you and the Commission will take in due consideration their concerns, I remain in the Consulate General of Portugal in Boston fully available to give any additional information that you may find useful or needed regarding the matter that is of great concern to the Portuguese and Portuguese-American Communities in all of Massachusetts.

I write today regarding the Federal Communications Commission's (Commission) Notice of Proposed Rulemaking, Amendment of Part 74 of the Commission's Rules Regarding FM Translator Interference.¹ Specifically in response to the proposed modification of 47 C.F.R. § 74.1203(a)(3), barring complaints of actual interference by listeners outside of WJFD-FM's 54 dBu contour. This proposed modification will have a devastating effect to the significant number of WJFD listeners outside of this contour who have relied upon WJFD's uniquely important broadcasts for over 35 years.

I. WJFD's Historic Concern to Reach Listeners Outside of the 54dBu Contour

My knowledge of this station stems from my relationship with the late Mr. Edmund Dinis—former prosecutor, Massachusetts State Representative and Senator—who attributed the “JFD” initials to WJFD.² Mr. Dinis would tell me of his concerns of the lack of radio options for the Portuguese immigrant population, mainly the construction workers who traveled from the

SouthCoast (comprising of Fall River and New Bedford), and continue to travel to this day, in search of the higher wages offered in Boston, Worcester and Cape Cod.

To respond to the demand for Portuguese programming, Mr. Dinis built a 600-foot tower to reach listeners outside of the 54dBu area—listeners traveling on Route 146 to the Massachusetts Turnpike to visit relatives in Hartford, Connecticut, hard-working people traveling to the Boston area on Route 93, and those travelling on the Lowell Connector.

To this day, I listen to WJFD on my weekly trips to and from Boston, which is outside the 54dBu contour. I am dismayed to learn that if the Medford translator is granted a license to use the 97.3 FM frequency, I will probably hear neither WJFD nor the new proposed Medford translator because it barely protects WJFD's 54dBu's area.

II. WJFD's One-of-a-Kind Radio Station

WJFD is uniquely Portuguese. It partners with Portugal's *Radio Antenna One* to broadcast national and international news, Portuguese soccer games between the three major rival teams, and daily news from the Azores and Cape Verde Islands. The station brings this news in addition to reporting from the New England area.

WJFD also sponsors Portuguese cultural events in the South Coast, and advertises them to those outside of its 54dBu contour. For example, notices for the "Day of Portugal" celebrations in New Bedford, Fall River, Providence, and Provincetown, and the largest Portuguese event in North America, "As Grandes Festas do Divino Espirito Santo da Nova Inglaterra" are broadcast on WJFD's airwaves and the station is a sponsor of all these events—offering live broadcasts for those who cannot attend, particularly those listeners outside of WJFD's 54 dBu's contour.

Furthermore, WJFD is a platform for Portuguese commercial products. The station broadcasts offers at the Portuguese, Azorean, and Cape Verdean grocers, shopkeepers, and restaurants on the South Coast to those outside of the 54dBu area.

Listeners outside of WJFD's 54dBu contour area have come to rely on WJFD for over 35 years as a link to Portugal, the Azores, and Cape Verde, and as a link to the abundant culture

found in the Massachusetts South Coast and Providence. This proposed rule will prove devastating to the Portuguese-speaking population in this WJFD community.

For the foregoing reasons, I hereby request that the Commission do not adopt the proposed modification to 74.1203(a)(3) "to state that no complaint of actual interference will be considered actionable if the alleged interference occurs outside the desired station's 54 dBu contour."

As Consul of Portugal in New Bedford and a direct witness of the action and importance of WJFD-FM within the Portuguese speaking community of New England, namely Massachusetts, I am joining my voice to those opposing the portion of your proposed rule that would prohibit existing broadcasters from contesting FM translators on their frequency if the translator is located outside the broadcaster's 54 dBu contour.

WJFD-FM stands alone in its service to the Portuguese and Portuguese – American community since 1950. Its commitment to quality shows through its careful and meticulous selection of content, music, professionals and a clear effort to invest in new equipment such as a new broadcasting tower.

Just a commitment and investment by a community radio would not make sense if the listeners base did not exist, if the demand for its services and presence was not necessary and sought after. In MA and RI alone is estimated the existence of 372,193 Portuguese and Portuguese-Americans (American Census, 2016 American Community Survey 1-Year Estimates).

It is my firm belief that WJFD – FM not only provides a quality service to its wide range of listeners but also a unique one that cannot be replicated by other stations. The proposed rule's impact would be devastating, especially to the listeners base in Worcester, Newton Waltham and Medford. To all WJFD is more than a radio, it is an expression of their cultural identity and a symbol of the Portuguese-American integration and acceptance in the United States.

When bearing in mind that WJFD is the sole Portuguese radio with FM footprint, rapidly becomes clear its influence in the perception of inclusiveness in US society by the Portuguese-American community of New England, as a resource that helps different generation to “fit in” and to celebrate its heritage in a multicultural and globalized world.

Additionally, a radio such as WJFD improves awareness of solutions to community issues. As an example, I wish to highlight WJFD role in promotion of the NEWL exams centers, a recent initiative and of key importance to those learning Portuguese (High School), as a second language in the US. Through the NEWL exam centers those students (regardless of nationality) may now receive credits that will be accepted at the University level.

WJFD has also served as an important link between different sectors of the Portuguese speaking community of New England: clubs, associations, bands, artists, schools and businesses. There is a clear connection between the programs and services offered by WJFD and the cultural heritage of the community. It is a major contributor to the quality of access of information by those that frequently travel by car, the elderly and those otherwise limited in their media options or even by language barriers.

WJFD is a solid marketing platform for local businesses from Northeast Massachusetts aiming at promoting their products to consumers in Southeast Massachusetts and vice-versa. A wide spectrum of cultural events, most of them organized by non-profit organizations of the community, depends on a radio such as WJFD thus strengthening the feeling of local ownership and participation.


It is also an important source of reliable news about Portugal, Massachusetts and the US with the added benefit of offering a content selection having in consideration potentially interesting subjects within its specific audience.

If the proposed rule passes as drafted, it is highly possible that WJFD-FM may no longer be able to ensure the clarity of its signal to all of its listeners of New England and above all hindering its fundamental contribution to the cultural cohesion between Northern and Southern Massachusetts, from Lawrence to Provincetown.

This is not a mere question of viability assessment; it is a matter of social and economic value without the resources of mainstream media for the benefit of the community, applied to a radio station with the characteristics and longevity of WJFD-FM.

Therefore, I wish to register my opposition to this portion of the proposed rule that would undermine the work of local stations and ask the Commission's fair and full consideration of efforts to retain the local broadcaster's ability to contest FM translators on their frequency.

I am writing to you as a State Senator from Rhode Island that has had the honor of representing the City of East Providence and the Portuguese-American community in Rhode Island since 1999. I have been an active leader in the Portuguese-American community on a statewide level and intimately involved in supporting Portuguese initiatives and celebrations prior to and since being elected to public office.

I am writing to you in regards to the Commission's proposed modification of Section 74.1203(a)(3) that would adversely affect many listeners of WJFD, who have relied upon WJFD's uniquely important broadcasts for over 35 years. I make these comments on the basis of my personal knowledge and on the basis of my position as a State Senator.

WJFD has been a significant presence in the Portuguese communities in the State of Rhode Island since its inception. As the only 50,000 watts Portuguese radio station in the United States, WJFD is relied on by hundreds of thousands for live daily news transmissions from Portugal, important community service bulletins and events, and a deep cross section of Portuguese music entertainment for all ages.

During the several waves of immigration that occurred during the 60's, 70's and 80's, most immigrants settled in the urban core of Providence and surrounding cities. As their economic prospects improved they began moving to other parts of the state, including northern Rhode Island which would be adversely affected by any proposed modification. I am an almost daily listener to WJFD and listen during my travels through the Route 146 corridor that connects Providence, Rhode Island and Worcester, Massachusetts. WJFD is not solely focused on the

Portuguese speaking community and has been an important partner for English speaking community organizations, elected officials and businesses that advertise to a large audience.

The Rhode Island Day of Portugal committee is a non-profit 501(c)3 organization that has been promoting and hosting annual cultural events in Rhode Island for forty-one years. In June, the yearlong events culminate into the largest Portuguese-American weekend festival in Rhode Island where many ethnic groups join in celebrating Portuguese culture, language and traditions. The events draw thousands of participants from Rhode Island, Massachusetts and neighboring states. The success of this annual event depends in part on the sustained promotional campaign on WJFD, including the Providence/Worcester corridor that would be adversely impacted by the proposed modifications.

For the foregoing reasons, I hereby request that the Commission not adopt the proposed modification to Section 74.1203(a)(3) "to state that no complaint of actual interference will be considered actionable if the alleged interference occurs outside the desired station's 54 dBu contour."

Dear Chairman Pai:

We are writing to oppose the portion of your proposed rule that would prohibit existing broadcasters from contesting FM translators on their frequency if the translator is located outside the broadcaster's 54 dB μ contour. Local, culturally important independent broadcasters located in gateway cities in our districts could be threatened by this rule change if they are not allowed to challenge FM translators emanating from central locations such as the Boston area.

For instance, WJFD-FM is an excellent example of an independent station with a strong history of serving the Portuguese-speaking population of Massachusetts and Rhode Island. As a 50,000-watt station, WJFD provides Portuguese news, music, and cultural programming that is accessible as far north as New Hampshire and as far west as Central Connecticut. WJFD provides a community resource to the many Portuguese-speaking residents of our districts and throughout southern New England. Recently, the community celebrated a very special Day of Portugal featuring a visit from the President of Portugal. The event included celebrating crowds not only in New Bedford and Fall River, but also in the capital cities of Boston and Providence, many of whom no doubt heard about the visit on WJFD.

WJFD reports that it has successfully opposed previous FM translator applications on its 97.3 frequency throughout its coverage area. If the proposed rule passes as drafted, the station is concerned it would no longer be able to ensure the clarity of its signal throughout southern New England, fundamentally harming WJFD's unique role as a cultural focal point for the Portuguese diaspora in the Northeast. Other independent stations in our districts also could suffer from the inability to protect their signals from FM translators.


The proposed rule states that this change would benefit less populous areas "where translators may offer the only local broadcast services." Clearly this is not the case in Massachusetts, where a relatively dense population means a crowded FM band, and where interference beyond the 54 dB μ contour renders a station like WJFD less viable. Therefore, we wish to register our opposition to this portion of the proposed rule that would undermine the work of local stations, and ask the Commission's fair and full consideration of efforts to retain the local broadcaster's ability to contest FM translators on their frequency.

We at MAPS were alarmed to hear that the FCC is considering decreasing WJFD-New Bedford's signal coverage area. We respectfully request that WJFD be allowed to continue to broadcast in its traditional area across the Boston metro area and beyond.

WJFD is a highly beloved radio station whose 97.3 FM frequency has been providing news, sports, music, and a variety of other programming in Portuguese to the large, diverse Portuguese-speaking community of this region—currently nearly half a million strong in Massachusetts alone, and the second largest linguistic minority group in the state—for more than 35 years. It is the only 50,000-watt FM radio station in New England broadcasting in the Portuguese language 24/7/365.

This station is the main source of information, cultural and community connections for a huge number of people, including Portuguese, Cabo Verdeans, and many Brazilians, as well as others from the Portuguese-speaking countries who live and work in New England. I myself grew up in Taunton listening to this station, and I still do, along with many friends, family members, and colleagues in Greater Boston, as well as southern New Hampshire. WJFD shows are also a valuable resource for MAPS. As a nonprofit, community-based organization serving all Portuguese speakers, MAPS has promoted its culturally and linguistically competent health and social services through media releases, interviews, paid ads and public service announcements on the station since we opened our doors in 1970. The station management and hosts have been wonderful community partners all along.

WJFD provides a vital service for tens of thousands of listeners. Jorge Moraes and other station representatives also participate in, support and cover community events and news throughout the year. WJFD programs are part of Portuguese-speaking life here, and reducing the coverage area would be a huge loss.

I urge you to please keep WJFD a strong and vital broadcast presence by maintaining its current broadcast range. Thanks very much for your consideration, and please do not hesitate to contact me if you have any questions or would like additional testimony.

I am writing regarding the Federal Communications Commission's Notice of Proposed Rulemaking, Amendment of Part 74 of the Commission's Rules Regarding FM Translator Interference.¹ Specifically in response to the proposed modification of 47 C.F.R. § 74.1203(a)(3), barring complaints of actual interference by listeners outside of WJFD-FM's 54 dBu contour. If implemented, this modification would have a devastating impact over 3 major ethnic minorities – Portuguese, Cape Verdean and Angolan – constraining air waves' cultural diversity and silencing a voice that for over 35 years have been providing an essential service for a large number of lusophone listeners, mainly U. S. citizens of ethnic Portuguese, Cape Verdean, Angolan and Mozambican heritage, residing in Eastern Massachusetts, Western Rhode Island and Northeastern Connecticut.

I. Ethnic Radio and WJFD's Historic Effort to Reach Listeners Outside of the 54dBu Contour

As a researcher and college lecturer of Ethnic Media, I can affirm of the cultural importance of this unique broadcast that not only carries distinct content in Portuguese but provides crucial news and information no other radio venue provides outside of WJFD-FM's 54 dBu contour. It should also be highlighted that WJFD is frequently the forum for all main issues affecting the Portuguese (namely Azoreans, Continental and Madeiran), Cape Verdean and Angolan ethnic minorities, with high focus on the political and electoral participation. Barring WJFD-FM outside the 54 dBu contour would disfranchise these ethnic minorities and silence a fundamental civic dialogue.

Participation of lusophone ethnic minorities in the democratic process was the main reason for WJFD's founder, Edmund Dinis², building a 600-foot tower to reach listeners in Eastern Massachusetts, Western Rhode Island, Northeastern Connecticut and coastal areas, exactly the ones outside of the 54dBu area. This effort was also a response to the requests for Portuguese programming by three major groups of listeners:

- 1-Portuguese and Cape Verdean fishermen from New Bedford, Provincetown, Gloucester and Nantucket out in the sea.
- 2-Portuguese and Cape Verdean construction workers traveling to the Metro Boston area on Route 93, as well as listeners traveling on Route 146 to the Massachusetts Turnpike and to visit family in Eastern Connecticut, and those travelling on the Lowell Connector.
- 3-Portuguese, Cape Verdean and Angolan residents in the Boston metropolitan area and Eastern Massachusetts, Western Rhode Island and Northeastern Connecticut.

II. Ethnic Radio, from Content Diversity to Community Radio

Ethnic radio is a major component of minorities discourse and civic participation. Shutting down WJFD's broadcast is to silence a fundamental voice for ethnic communities. If FCC rules for limiting WJFD's broadcast outside of its 54dBu contour it will not only limit diversity it will silence a voice.

Due to the pattern of ethnic communities' geographical distribution in hubs, by providing ethnic content in Portuguese language WJFD embodies a dual nature of ethnic and community radio. Out of its WJFD 54dBu contour, Portuguese, Cape Verdean and Angolan communities have no other equivalent radio venue to get local community news and information, with local correspondents. Silencing this community voice means a total black out.


There is also no similar radio in terms of Portuguese content: WJFD partners with Portugal's Public Radio *Antena 1* to carry national and international news, sports news, live coverage of Portuguese soccer games and daily news from the Azores and Cape Verde Islands (two major components of its programming). Another major WJFD uniqueness is the live coverage of Portuguese cultural events in the South Coast (the largest concentration of Portuguese-Americans in the U. S.), promoting and advertising them to those outside of its 54dBu contour. Without WJFD, major ethnic events like the New England 'Grandes Festas do Espírito Santo', Day of Portugal celebrations (in New Bedford, Fall River, Providence, Lowell and Provincetown) and the Madeiran Feast, in New Bedford, would be disconnected from the communities outside of the 54dBu contour.

Finally, it would be disastrous for small ethnic business to be silenced out of WJFD because of a 54dBu contour shut down. WJFD is an essential market platform for Portuguese ethnic products. The station broadcasts information and advertisement to the Portuguese, Cape Verdean and Angolan small business (ethnic services, importers, grocers, shopkeepers and restaurants) on the South Coast to those outside of the 54dBu area.

Thousands of listeners outside of WJFD's 54dBu contour area have come to rely on WJFD for over 35 years as a cultural cement, a communities' bridge and a multicultural link to Portugal, Cape Verde and Angola. WJFD is a fundamental and unique link to the abundant multiculturalism found in the Northeastern New England. This proposed rule will prove devastating to the Portuguese-speaking ethnic groups in multiple communities served by WJFD.

For the foregoing reasons, I hereby request the Commission to preclude the modification to 74.1203(a)(3), regarding interference by listeners outside of WJFD-FM's 54 dBu contour.

Dear Chairman Pai:

I am writing to you in my capacity as a member of the Portuguese-speaking community of Southeastern Massachusetts, a member of the Advisory Council of the Center for Portuguese Studies and Culture at the University of Massachusetts Dartmouth, the faculty director of the Ferreira-Mendes Portuguese-American Archives at the same university, a sociologist who has been studying and publishing about Portuguese-speaking groups in the U.S. for over 30 years, and as a listener of radio station WJFD, with a very urgent request: Please do not let the Federal Communications Commission adopt a rule that will prevent Portuguese speakers residing in the Boston Metro Area and adjacent communities from being able to listen to WJFD.

My reason for this request is that this modification would negatively affect the ability of Portuguese-language radio station WJFD of New Bedford, Mass., to reach its thousands of listeners in these areas, thereby having a profound negative impact on the survival of Portuguese-speaking cultures in the U.S. and the capacity of Portuguese speakers to participate in U.S. civic life as well informed citizens.

For over two centuries, the Portuguese have been settling in the Providence-Fall River-New Bedford Metropolitan Statistical Area, attracted initially by the whaling industry and later on by textiles and other types of manufacturing. Since the last quarter of the 20th century they have been joined by other Portuguese-speaking groups. As a result, in this area of over 1.6 million residents, about 19% or almost 300,000 are of Portuguese and Cabo Verdean ancestry (The U.S. Census does not provide data for other Portuguese-speaking groups, including Brazilians), and Portuguese is the third most-spoken language at home.

This area contains the highest concentration of WJFD listeners, but certainly far from all of them. In fact, as can be verified by U.S. Census data, in the last forty years, with the decline of manufacturing in areas of original settlement, and the increase in the cost of real estate in the Boston area, Portuguese-speakers have moved in large numbers away from their traditional



ethnic neighborhoods and into outlying geographical areas. As a result, large numbers of Portuguese speakers and WJFD listeners are also found in the Boston Metro Area, as well as in many other outlying communities in Massachusetts, such as Lowell and Peabody where, again, Portuguese is the third most-spoken language at home.

As a sociologist who studies immigration and ethnicity, I am keenly aware of the important role played by ethnic media in the forging and maintenance of ethnic culture and identity, as well as the fostering of diversity, inclusion and integration into mainstream American society. As various studies of immigrants have shown, unless some form of regular contact with the original culture is maintained, and individuals are able to receive information in their own language, as the process of geographical dispersion accelerates so does the weakening of ethnic ties, culture, identity and civic participation.

In the case of Portuguese speakers in Massachusetts, for the past 43 years, WJFD has been providing that regular contact with original culture and other co-ethnics living in the U.S., while supplying the information they need for successful integration into American society. Moreover, currently, WJFD is the only Portuguese-language radio station reaching Portuguese-speaking communities outside the Providence-Fall River-New Bedford Metropolitan Statistical Area. If the proposed modification of Section 74.1203 (a) (3) goes through, Portuguese-speakers in these outlying areas will no longer receive daily news from their homelands in Portugal, especially the Azores, and Cabo Verde; they will not learn about the various festivals and other religious and cultural events taking place in other co-ethnic communities throughout the U.S.; they will lose the opportunity to be aware of current public issues affecting Portuguese speakers in the U.S.; and they will be less informed about what is going on in the U.S. and the world. In sum, they will lose their culture and their ethnic identity, contributing to the impoverishment of American culture as a whole, while having their ability to be well-informed American citizens curtailed.

Please do not let this happen. Please stop the Federal Communications Commission from adopting a rule with such a significant adverse impact on these WJFD listeners.

I am writing you regarding the Commission's proposed modification to Section 74.1203(a)(3) that would compromise the broadcast range of WJFD 97.3 FM, the 50,000-watt radio station broadcasting in Portuguese to southeastern New England. My interest in WJFD is both personal and professional; not only was I born and raised in the area in which the station broadcasts to a wide range of listeners (I remember listening to WJFD as early as December of 1984), I also work as an associate professor of Portuguese at the University of Massachusetts Dartmouth, the local public university. From my contact with students from all over the Commonwealth of Massachusetts, I know how important a cultural resource this radio station is, whether they live in Peabody north of Boston, in the smaller towns of central Massachusetts, in the important Portuguese-American and Cade Verdean-American communities on Cape Cod and the Islands, or in nearby Rhode Island, where I currently reside.

Portuguese-speaking community members rely on WJFD for news, music, sports, and community interest programming from interview and call-in shows to coverage of traditional religious festivals. I am concerned that any modification to the broadcast range of the station would have a deleterious effect on access to the news and information that this station provides to so many listeners both in Portuguese-speaking population centers in the region and beyond. I cannot express how important this station is to me as part of my cultural identity, both as a Portuguese-speaking resident of New England, and as a US citizen committed to promoting the free and open expression of a wide range of ideas and cultural perspectives. For all of these reasons, I request that the Commission not adopt the proposed modification specified above and not allow any infringement of WJFD's 54 dBu contour.

To the Honorable Alij Pai:

My name is Anibal Serra and I am a Portuguese teacher at Hudson High School. It is my fourth continent teaching Portuguese (after East Timor, Southeast Asia, Sao Tome and Principe, Africa, and Portugal, Europe) and, except for Portugal, no other community I met had the opportunity that Hudson has had throughout these years to be able to enjoy the public and community service that a radio station like the WJFD provides.


In my four years of residence and work in Hudson, the presence of WJFD was a personal bridge to my culture and a useful link between my personal life and my work as a teacher of Portuguese language and culture. At Hudson High School we have about 300 students enrolled in Portuguese courses and without access to other means of access to the language, radio was a privileged source to contact with it after school, in a real-life context. Many summer activities consisted of following some of the programs to consolidate learning and to maintain reinforced interpretive skills during school breaks. Removing these students access to the WJFD means taking one of the most important language learning tools that our community has had so far.

Besides that, since 2017, Hudson Public Schools received a grant from the federal government to teach Portuguese to elementary school children. The name of this program is Startalk (<https://startalk.umd.edu/public/>) and it is designed to increase the number of students enrolled in the study of critical-need languages such as Portuguese. The Office of the Director of National Intelligence (ODNI) launched STARTALK and delegated executive oversight of the program to the National Security Agency (NSA). The NSA in turn awarded a contract to the National Foreign Language Center (NFLC) at the University of Maryland (UMD) to act as its subject matter expert in the implementation and administration of the program. Hudson Public Schools is now one of the institutions part of this national program and WJFD is a significant part of the curriculum designed for our courses. We even take our students in the summer to WJFD in a field trip. If the Federal government is investing in Portuguese and in particular in Hudson, losing access to WJFD is a strong contradiction to a national policy, a cut in a significant and strategic path for the growth and spread of language learners of Portuguese. On the one hand, the US government tries to increase the number of U.S. citizens learning and speaking critical need foreign languages, on the other hand, we lose in our community the instrument that has been somehow doing that job for so many years. I find it hard to understand and see it as a long-term mistake.

Hudson Public Schools is also brainstorming a plan to recreate a bilingual education program in the district (existed in the past in the 1980-90), this tells you how important Portuguese is for our town. Having media in Portuguese is a critical mean to this end since having different sources to learn a language and to develop fluency and proficiency is fundamental to the implementation of programs like this. WJFD is the perfect match to this idea, the right complement, not only for their quality but also for the variety of content provided.

As you can see, the presence of WJFD in Hudson is not only a guarantor of the conservation and enhancement of the linguistic and cultural heritage of an influential and integrated community in the region, it is also an instrument of extreme utility in the implementation of local and national educational and cultural policies.
