I am writing regarding Billerica Public Schools 205 – BEN 120371.
Please see attached FCC Public Notice, approval listed on page 5.

Billerica Public Schools submitted an FCC appeal pertaining to Funding Year 2015 invoice extension. The appeal was submitted on April 11, 2017 and approved on FCC Public Notice dated April 28, 2017. I never received notification directly from USAC regarding this decision. I created a case on 6/8/2017 (case # 182282) requesting an appeal status update, I was informed that USAC received the FCC decision notice but must also approve the decision and has 90 days from the release of the Public Notice to make a decision.

Since the 90 day decision deadline is next week, I again created a case (case # 187224) today to inquire of the status and was informed that FRN 2832554 was updated with the last date to invoice of 7/16/2017. I never received any notification of the approval by USAC, usually in matters similar to this USAC sends a letter notifying the applicant of the final decision. Since no notification was given the deadline of 7/16/2017 passed unknowingly.

Please allow a new last day to invoice so the district is able to collect their reimbursements.
