Good Morning Tracey,

This is very alarming. We submitted SLD Invoice 2764432 Line 9036055 under the guidance that the Form 486 Notification Letter found within the EPC News Brief was the deciding factor to determine whether or not a FRN was "ready for invoicing" even if EPC displays "In Review" and the FRN Status Tool 486 SSD is blank.

Needless to say **SLD Invoice 2764432 Line 9036055 was rejected** on 02/08/2017 for the following reason: "**No Form 486 Filed or Form 486 Missing Start Date**"

Again, under guidance from USAC that this is simply a display error and a new invoice would be paid as they were able to confirm the date in which the 486 notification was sent to the Customer. Under USAC's guidance we proceeded to submit **SLD Invoice 2772218 Line Item 9051563**. In addition to the new invoice we opened Case 224912 to track the processing of the invoice. The Case was closed as shown below, further describing the "error" and that the 486 notification was accurate. Remittance statement received on 02/22/2018 for SPIN 143048275 includes a REJECTION for **SLD Invoice 2772218 Line Item 9051563** due to **No Form 486 Filed or Form 486 Missing Start Date**.

We are losing confidence in USAC rather quickly.

Please advise on next steps as we are nearing the Last Day to Invoice deadline on 02/26/2018.
