**SUPPLEMENT TO PETITION FOR ELIGIBLE
TELECOMMUNICATIONS CARRIER DESIGNATION**

Sunset Digital Communications, Inc. (“SDC Inc”) hereby supplements its above-captioned Petition for Eligible Telecommunications Carrier (“ETC”) Designation (“Petition”) in the states of Tennessee and Virginia as follows.¹

As a consequence of and following the August 6, 2019 *Order* granting the requested waiver of the major ownership change provisions of Section 54.315(b)(6)(iv) of the Commission’s rules,² SDC Inc has consummated the assignment of its rights and obligations as a Connect America Fund (“CAF”) Phase II Auction winner to Sunset Digital Communications, LLC (“SDC LLC”), and SDC LLC has assumed those rights and obligations. The parties also have amended SDC Inc’s Auction 903 long-form application to substitute SDC LLC as the applicant.³
