Hi Julann,

I wanted to let you know that the self-identified appeal I had processed on your behalf was rejected by USAC. The deadline to file a self-ID appeal is 60 days from the FCDL date. They did state however that you can directly file an appeal with USAC and they will review the file and provide determination.

My best recommendation would be to contact the USAC helpline at 1-888-203-8100 and they can walk you through the process of filing appeal directly with USAC. I think your FCDL should have information also.

I wish I could have processed the appeal on my end but unfortunately program rules do not allow it. I do apologize about the late response. I was out of the office the last week and a half due to a death in the family.
