**Re: *Promoting Telehealth in Rural America*, WC Docket No. 17-310; *Rural Health Care Support Mechanism*, WC Docket No. 02-60**

Dear Ms. Dortch,

In a discussion with staff about the availability of rate information for certain services, AT&T agreed to provide retail rate information that it makes publicly available on its website for access services that are frequently discounted through the Rural Health Care Telecom Program. The attached information is available through the “AT&T Bandwidth Services” Service Guide at [https://serviceguidenew.att.com/sg\\_landingpage?tgtPg=sg\\_homecontentpage](https://serviceguidenew.att.com/sg_landingpage?tgtPg=sg_homecontentpage).

Rate information is available through this Service Guide for T-1s and, among other things, switched Ethernet access channels ranging in speeds from 2 Mbps to 1 GB. The Service Guide also contains historical rate information for these services. AT&T’s T-1 pricing is nationwide, which means AT&T’s T-1 rates are the same in urban areas and in rural areas. Its switched Ethernet rates are provided across just over 100 zones. The zones correspond to the identity of the underlying provider. AT&T’s rates where an AT&T affiliate is the incumbent local exchange carrier (ILEC) (Zones 1, 1A, 2, and 2A) are generally lower than where AT&T obtains the access from a non-AT&T ILEC (Zones 3 through 101C).<sup>1</sup> Similarly, AT&T’s rates in Zones 1A and 2A are slightly lower than its rates for Zones 1 and 2. Zones 1A and 2A encompass competitive serving wire centers. For example, the list price for a 50 Mbps Ethernet circuit in Nashville, Tennessee, which is served via a competitive wire center (e.g., NSVLTNDO), is \$1,134.00/month and is \$1,359.15/month in a non-competitive serving wire

center in Tennessee. Additionally, AT&T offers significant discounts off of its list prices for customers that sign contracts ranging in length from 12 months to more than 60 months.

Attached to this letter are several excerpts from the “AT&T Bandwidth Services” Service Guide that provide some of the information described above. However, other information is accessible via hyperlinks embedded in the Service Guide and some of that information is displayed in spreadsheets that are not conducive to converting to a pdf document. For example, details about AT&T’s Zones are found in twelve tabs, accessible via the “Current Zone Definitions” link, found on page 93, among other pages. Similarly, AT&T’s switched Ethernet access channel rate information, available via a link on page 132, is provided in over 100 columns, each corresponding to a zone.

Please let me know if you have any questions about the rate information AT&T makes publicly available in its service guides, including the “AT&T Bandwidth Services” Service Guide.
