Thank you for your response. We are still trying to get E-rate reimbursements from work completed in summer/fall of 2016 but we are unable to get the request approved until the steps above have been properly completed. Since the last email someone has gone back in and completed the form for 2018-2019 but it also needs to be completed and signed for 2016-2017. If you did any E-rate work for other schools in 2017-2018 I would recommend doing it for that year as well while you are in there but we only need it for 2016-2017.

As you can see below the 2018 in the far right column indicates it was completed for 18-19 but that will also list 2016 and 2017 once you complete the form for those other two years as well.
