**ORDER FOR CUSTOMARY ADMINISTRATION OF  
PSYCHOACTIVE MEDICATION**

On the 3RD DAY OF MAY, 2018, came to be heard the Application for Order to Authorize Customary Administration Of Psychoactive Medication in the above styled cause, alleging that TARA SING JENNINGS, hereinafter called Patient, is subject to Application or an Order for court-ordered mental health services under §574.034 of the Texas Health and Safety Code, and both the attorney for the State and the attorney for the Patient having announced ready, and all matters of fact and law having been submitted to the Court, the Court finds:

That all necessary notices and copies of the Application have been served as required by law and that all of the terms and provisions of the Texas Health and Safety Code have been complied with;

That on file with this Court in this cause is a verified Application by the Patient's physician who has examined the Patient and therein states the physician's detailed basis to determine that the Patient is in need of psychoactive medication but lacks the capacity to make a decision regarding administration of said medication and that it is in Patient's best interest to have psychoactive medication; and

That after considering all of the evidence, including the Application and the expert, competent medical or psychiatric testimony, it appears to the Court that the allegation in the Application are true and correct and are supported by clear and convincing evidence.

It is therefore determined that the Patient is under an Order for Temporary Mental Health Services; that treatment with the proposed medication is in the best interest of the Patient; that the Patient lacks the capacity to make a decision regarding administration of said medication and that the same shall be ordered.

It is also **ORDERED** that during the period this Order is valid, the dosage of the herein authorized class(es) of psychoactive medication can be increased or decreased, and restitution of medication authorized but discontinued and the substitution of a medication within the same class(es) are permitted.

This Order expires on the expiration or termination date of the Order for Temporary Mental Health Services, dated **3RD DAY OF MAY, 2018**.

A copy of this Order provided to the Patient and the Patient's attorney shall serve as written notification of the court's determination.
