Paul C. Besozzi and Koyulyn K. Miller, counsel to Adak Eagle Enterprises, LLC (AEE), met with several Federal Communications Commission (FCC) staff regarding the pending Petition for Reconsideration (PFR) filed by AEE¹ requesting reconsideration of the FCC's decision to deny AEE a second offer of support under the Alternative Connect America Cost Model (A-CAM) pursuant to the December 20, 2016 Report and Order and Further Notice of Proposed Rulemaking.²

On August 10, 2017, Mr. Besozzi and Ms. Miller met with the following staff in the Telecommunications Access Policy Division of the Wireline Competition Bureau: Ryan Palmer, Chief; Alexander Minard, Deputy Chief; and Dana Zelman, Attorney Advisor. Also

in attendance from the Wireline Competition Bureau front office was Katie King, Legal Advisor.

The primary purpose of the meeting was to inquire as to the status of the pending PFR. Specifically, counsel inquired as to when AEE might expect a decision on the PFR, especially given that there were no oppositions filed, and indeed, one letter of support was submitted in response to the relevant Public Notice.³

Undersigned counsel requested that a final decision be issued as soon as possible, thereby allowing AEE to better plan its operations and expenses going forward.

Finally, counsel also offered to answer any additional questions from staff and to provide further information upon request.
