



Patrick Gills, brother, which I have been staying with for the months of May, June, and will continue to stay with until further notice. I pay him \$450.00 a month for rent only.


I will submit food, gas receipts, rental of car, and etc. for reimbursement for my lodging for relocating to Fort Worth, TX with my two kids.


