On August 15, 2017, Alex Quilici, CEO of YouMail, Inc. and the undersigned met separately with:

- 1) David Grossman, legal advisor to Commissioner Mignon Clyburn.
- 2) John Adams, Jerusha Burnett, Micah Caldwell, Christina Clearwater, Karen Schroeder, , Richard Smith, Mark Stone, Kristi Thornton and Patrick Webre of the Consumer Bureau and Henning Schulzrinne of OSP.
- 3) Rosemary Harold, Richard Hindman and Kristi Thompson of the Enforcement Bureau.
- 4) Nirali Patel, legal advisor to Commissioner Brendan Carr.

During these meetings YouMail discussed how its intelligent enhanced services apps and platform are used to stop unwanted robocalls. The company estimated that its patented technology has stopped more than 500 million robocalls. YouMail uses various databases, customer feedback and smart algorithms to classify calls as high, medium and low risk; with customers always having the option to white list wanted callers. The YouMail service works with wireless carriers and VoIP providers that expose conditional call forwarding.

YouMail's Robocall Index is used by the FCC and others to determine robocall quantities nationally and locally. For example, YouMail estimated that 2.5 billion

robocalls (including 15.9 million calls in area code 202 alone) were placed nationwide in June 2017. The company offered to work with the Commission on resolving robocall complaints.

YouMail and the meeting attendees briefly discussed the above-referenced dockets. The attached presentation was provided to meeting participants.

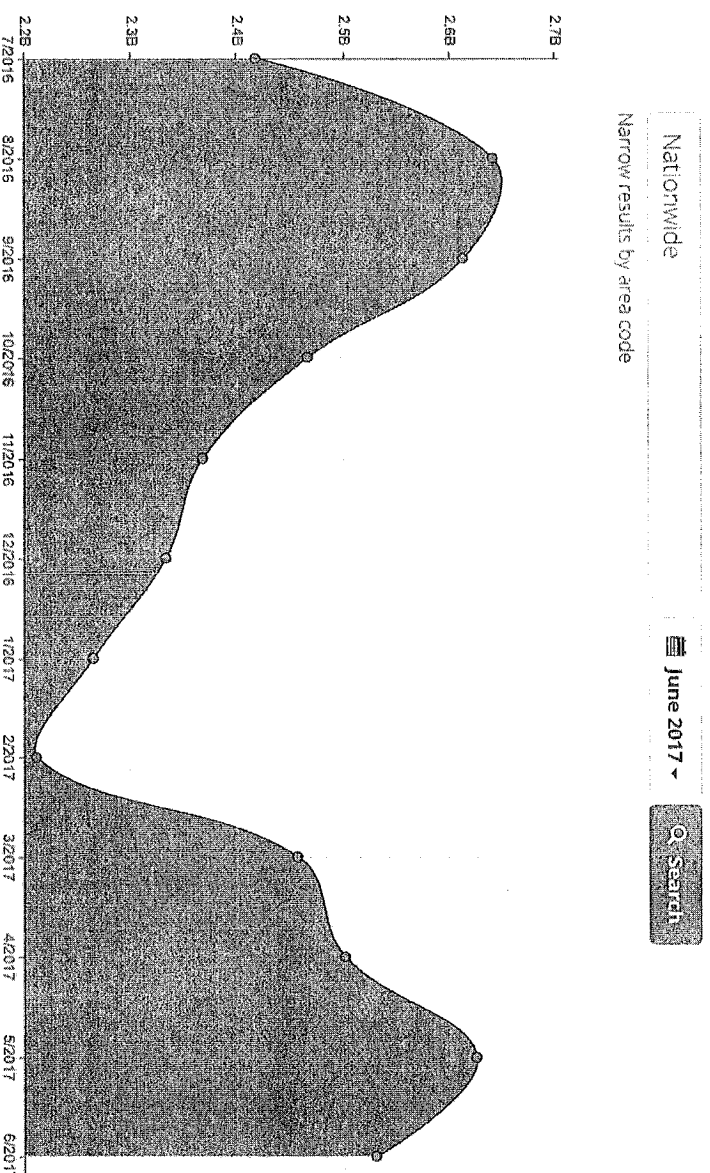


YouMail Robocall Index

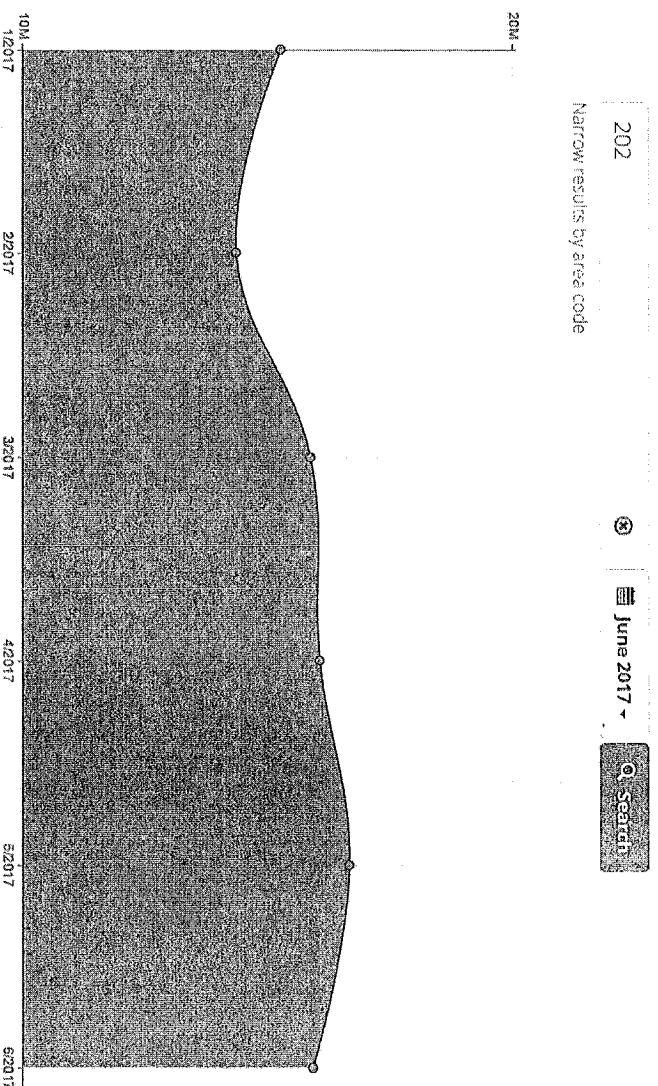
