**Description of Network Changes Planned:**

BellSouth Telecommunications, LLC d/b/a AT&T Georgia intends to retire and remove copper distribution facilities serving distribution area (DA) 311512 in the Flowery Branch (FLBRGAMA) wire center as the result of a Georgia Department of Transportation (GDOT) road widening project. GDOT has notified AT&T Georgia of its project to expand Spout Springs Road between Union Circle and Hog Mountain Road in Flowery Branch, Georgia. This project will affect all existing copper cables in DA 311512. GDOT has requested that AT&T Georgia remove the impacted copper facilities by no later than February 29, 2020. AT&T Georgia will migrate customer services currently on the impacted copper cables to an existing Gigabit Passive Optical Network/Fiber-to-the-Premises (GPON/FTTP) overbuild of the DA and then retire the copper cables.

There are currently 87 working circuits impacted by this project, and notifications are being sent to those customers to prepare for migration to the new fiber-based network.

**Description of Reasonably Foreseeable Impact of the Planned Changes:**

After the implementation date, copper feeder and distribution cables in DA 311512 will no longer exist, and unbundled loops requiring copper facilities, e.g., digital subscriber line (DSL) or line-sharing circuits, will no longer be available in this DA. AT&T Georgia has no record of any competitive carrier circuits currently assigned over copper facilities in DA 311512.
