Dear Ms. Dortch:

On August 4, 2017, CenturyLink, Inc. (“CenturyLink”) and Level 3 Communications, Inc. (“Level 3,” and together with CenturyLink, the “Applicants”) submitted Highly Confidential data [Bates Number CTLLVLT-000155] demonstrating the extent to which demand for BDS meets or exceeds the equivalent of two DS-3 circuits in certain 2:1 locations in CenturyLink’s ILEC region.¹ The *ex parte* presentation accompanying the August 4th submission explained that the Applicants previously had identified a total of 529 2:1 locations in which a fiber-based competitor is located within 0.1 mile.² The August 4th submission provided demand data for 454 of those locations.³

In this submission, the Applicants are filing a Highly Confidential spreadsheet [Bates Number CTLLVLT-000161] that provides demand data for the 75 remaining 2:1 locations that were not included in the August 4th submission. For convenience, the Applicants also are resubmitting the demand data provided in their August 4th submission so that demand data for all 529 2:1 locations can be found in one file.⁴ The data submitted herewith demonstrates that 94

percent of the 529 2:1 locations that the Applicants previously had identified have demand that meets or exceeds two DS-3 circuits or are stand-alone cell towers or DSLAM locations.⁵
