Dear Ms. Dortch:

Pay Tel Communications, Inc. (“Pay Tel”), through counsel, submits this amendment to its response to the Commission’s Mandatory Data Collection filed March 1, 2019, with the Commission in the above-referenced proceeding.

It has come to Pay Tel’s attention that three data fields were unintentionally omitted from Pay Tel’s March 2, 2019, Mandatory Data Collection (FCC Form 2300) filing, specifically the “Total Paid MOU” fields for Facility 63 (2016), Facility 65 (2017), and Facility 68 (2018). This amendment is made to provide the omitted data for these three fields.

In accordance with the Wireline Competition Bureau’s Public Notice in WC Docket No. 12-375 dated February 14, 2019 (DA 19-85), and using the procedures specified in the Protective Order issued by the Bureau on December 19, 2013,<sup>1</sup> a redacted, public version of the above-referenced amendment is being submitted with this letter. The unredacted amendment pages contain confidential commercial, financial, and technical information disclosure of which will likely would cause substantial competitive and financial harm to Pay Tel. Accordingly, a copy of the confidential version of the amendment is being submitted separately to the Commission under confidential seal, along with a native file copy of the as-amended Mandatory Data Collection form.
