

Dear Ms. Dortch:

In its June 10, 2016 Application for Review in the referenced cases, PMCM TV, LLC indicated that it planned to seek emergency relief from the Court if the Commission did not act by July 15, 2016. On further reflection, PMCM believes the Commission may need more time to evaluate the issues presented in the first instance. Accordingly, PMCM hereby advises the Commission that, given the exigencies of the situation and the limited timeframe of the protections provided by the Spectrum Act, it plans to seek judicial relief if the Commission has not acted by August 10. That will afford the Commission a full two months to review the AFR and the associated pleadings.
