Specifically, Verizon is providing notification of the replacement of copper distribution and loop facilities with fiber-to-the-premises facilities at all remaining locations in the Annandale, Alexandria, Barcroft, Burgundy Road, Cameron, Franconia, Mount Vernon, Arcola, Arlington, Crystal City, Ashburn, Bethia, Chester, Chancellor, Chancellor 2, Churchland, Deep Creek, Culpeper, Centreville, Crittenden, Dale City, Fredericksburg, Lee Hill, Braddock Road, Fairfax, Great Bridge, Battlefield, Great Falls, Groveton, Aberdeen Road, Drummonds Corner, Queen Street, Hopewell, Dulles Corner, Herndon, Sterling Park, Haymarket, Independent Hill, King George, Gunston, Lorton, Leesburg, Mechanicsville, Lewinsville, Midlothian, Manassas, Nokesville, Huntington, Harpersville, Jefferson, Nettles Drive, Yorktown, Occoquan, Purcellville, Princess Anne, Providence Forge, Petersburg, Hodges Ferry, High Street, Cogbill, Rich - Gaskins Road, Grace Street, Gayton Road, Hull Street, Hermitage, Hungary Spring, Turner Road, Logan, Pemberton, Patterson, Randall Avenue, Sandston, Stephens City, Stafford, Toano, Triangle, Vienna, Chinese Corner, Indian River Road, Plaza Trail, Robbins Corner, Salem Road, Virginia Beach 32nd St, Williamsburg, and Winchester, VA wire centers. Upon completion, Verizon will provide services available over its fiber optic network.

The majority of customers served by copper at these locations purchase "plain old telephone service." Following transition to fiber, Verizon will continue to offer these customers the same POTS over fiber at the same price as they received on copper facilities, with no change in the underlying features and functionalities in their service.

**Description of the planned network change(s):**

Verizon intends to retire the copper facilities at all remaining locations in the eighty-five (85) wire centers listed above. Verizon has deployed or plans to deploy its fiber-to-the-premises network in these areas and intends to provide services over a fiber network infrastructure. Updating our network from copper to fiber benefits our customers because of fiber's resiliency and reliability, especially in inclement weather. Fiber also provides our customers with expanded capabilities to grow with current bandwidth demands for their home or business.

**Description of reasonably foreseeable impact(s) of the planned change(s):**

After the retirement of the copper facilities, Verizon will: (1) no longer offer services over copper facilities; and (2) cease maintaining the copper facilities. To help ensure an orderly transition, Verizon may require customers and interconnecting entities to migrate services off of copper facilities well before the copper retirement implementation date.
