In accordance with Sections 54.719 through 54.721 of the Commission's Rules, Hamden Hall Country Day School, through its consultant, requests an FCC Waiver of the Form 472 filing deadline for Funding Year 2015.

Please Note: This is a supplemental filing, to provide clarified detail for the review of this waiver. The original letter was submitted to the FCC through the ECFS system on June 14th, 2017.

Hamden Hall, through its E-Rate consultant, filed an Invoice Deadline Extension by mail on October 27th, 2016. The letter was sent a precaution due to issues that had been experienced with the Online Bear System during that timeframe. Prior to the letter being sent, the following FRN's had their deadline(s) extended: FRNs 2761566; 2761571 & 2761620 on October 21st, 2016. FRN 2761629 was not extended, even though it was included in both the Invoice Deadline extension letter dated October 27th 2016, and was also entered as an online deadline extension request on October 21st, 2016.

The basis of the need for the deadline extension at that time, was due to the length of time needed for the schools Form 498 to be approved. USAC also did not provide a response to the letter dated October 27th, 2016. As of the date of the letter, October 27th, 2016. The Form 498 was still not approved, or appearing in the online BEAR system.

An appeal was filed with USAC regarding the Invoice Deadline extension, and subsequently "denied" with a statement that the Invoice Deadline Extension was not filed in a "timely manner" we contend that both BEAR filing system issues, along with the lengthy approval process for the form 498, as well as USAC omission, prevented the extension from being processed.



At this point, Hamden Hall's only recourse in collecting these reimbursements is in filing this FCC waiver. We hope that after review, the FCC will rule that Hamden Hall did everything in its power to file a deadline extension in a timely manner.

We look forward to your ruling.

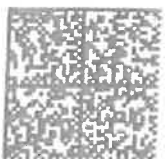
