Dear Ms. Dortch:

In various submissions filed in this proceeding, CenturyLink, Inc. (“CenturyLink”) and Level 3 Communications, Inc. (“Level 3,” and together with CenturyLink, the “Applicants”) have reported the presence of fiber-based competitors in proximity to 2-1 overlap locations in CenturyLink’s ILEC region.<sup>1</sup> In response to a request from the staff of the Commission’s Wireline Competition Bureau, the Applicants submit herein Highly Confidential data [Bates Number CTLLVLT-000179] containing demand information for 206 of those 2-1 locations.<sup>2</sup>

References in CTLLVT-000179 to the provision of Wavelength service are based on the presence of Wavelength equipment at the location. Although the Applicants are in the process of verifying that Wavelength service is being provided at the location, the Applicants believe that, given the cost of this equipment and the ability to move it to another location, this equipment would not be present absent the provision of Wavelength service at the location. References to “Stand-Alone ILA” in CTLLVT-000179 refer to locations in which “Intermedia Light Amplification” equipment is present. The Applicants believe that the competitive significance of locations with this equipment is akin to locations that contain stand-alone DSLAMs.
