Request for Waiver
FCC Form 472 Invoicing Deadline for Funding Years 2016 & 2017

We are requesting a waiver of the invoicing deadline for the FRNs listed in Table 1.

We filed SPIN Change requests or Form 498 (South Jefferson CSD only) prior to the respective invoicing deadlines. However USAC did not issue decisions on our requests until after the respective deadlines.

Generally, post deadline decisions have been automatically granted invoice deadline extensions. Delayed decisions have also been automatically granted extensions in the past. Please note that we waited for over a year for an update on the SPIN changes submitted for Broome-Tioga BOCES for Funding Year 2016. During that time USAC could not provide any information or status updates on our requests.

Since the various decisions have been issued, we've waited for the invoice deadline extensions to follow. In some cases, we've tried to file BEARs just in case the extensions were granted without any communication. At this time we would like to seek relief in the form of a waiver of the deadline. Please grant these waivers and allow us an extension of the invoice deadlines.
