**OPPOSITION OF CHOCTAW HOLDINGS, LLC
TO PETITION FOR RECONSIDERATION OR IN THE ALTERNATIV FOR RELIEF
UNDER SECTIONS 1.41, 1.2 AND OTHER RULES**

Choctaw Holdings, LLC (“Choctaw”) hereby opposes the Petition to Reconsideration or in the Alternative for Relief Under Sections 1.41, 1.2 and Other Rules filed by Warren Havens and Polaris PNT PBC (“Havens”) on August 25, 2017 (the “Petition”). Havens does not have standing to file the Petition which is merely the latest meritless pleading he has filed with the Commission.

The Commission should promptly dismiss or deny the Petition. In addition, the Commission should consider the imposition of sanctions if Havens continues to file meritless pleadings, especially where he has no standing.
