With this letter Detroit Service Learning Academy ("DSLA") appeals a decision by the Universal Service Administrative Company ("USAC") to set the Service Start Date for each of the captioned Funding Requests (the "Funding Requests") later than the first day of Funding Year 2016¹, and prays that for each Funding Request the Service Start Date will be set to July 1, 2016.

Background

DSLA is a unique educational institution which integrates meaningful community service with instruction and reflection to enrich the learning experience, teach civic responsibility, and strengthen communities. As members of the community, DSLA students have the responsibility to live the core values of wisdom, justice, integrity, love, compassion, respect, and courage. DSLA relies on funding under the Schools and Libraries Universal Service Support Mechanism (commonly known as "E-Rate") as a critical component of the financial resources it requires to fulfill its educational mission.

USAC records show that on December 12, 2016, USAC Issued a Funding Commitment Letter committing funding to each of the Funding Requests². According to USAC procedures DSLA should have filed FCC Form 486 citing each funded Funding Request not later than April 11, 2017³. However, in the event that a Revised Funding Commitment Decision Letter ("RFCDL") is ultimately issued, it would be the date of the RFCDL from which the 120-day deadline is calculated.

On August 4, 2017, DSLA completed and certified FCC Form 486 No. 57577 citing each of the Funding Requests, and stating a Service Start Date of July 1, 2016. The apparent late filing came as

a result of staff shortages, staff changes, and confusion over the filing deadline. However, DSLA's concerns about actually having put funding at risk was mitigated by its cognizance of the policy set in the *Archdiocese of New Orleans Order*⁴, in which the Federal Communications Commission (the "Commission") directed USAC to set the Service Start Date to the first day of the funding year in cases of late-filed FCC Forms 486 that were filed no later than 120 days after the last day to receive service for the funding request at issue, and where the applicants have demonstrated good cause for the late filing.

Subsequent to DSLA's FCC Form 486 filing, USAC issued a Revised Funding Commitment Decision Letter ("RFCDL") on August 9, 2017⁵. DSLA's August 4, 2017 FCC Form 486 submittal was prior to 120 days after the RFCDL date; therefore, as a result of USAC's issue of the RFCDL, DSLA's FCC Form 486 was submitted early enough to be in compliance with USAC's procedures.

DSLA conscientiously took steps to monitor the status of the late-filed FCC Form 486, as DSLA was aware of the Commission's requirement to file any necessary request for review not later than 60 days after the date of an adverse USAC decision⁶. In an abundance of caution, DSLA monitored the form's status using three independent sources.

First, DSLA monitored received email for any notification that USAC had completed its review of the FCC Form 486. To the best of its knowledge and belief, DSLA never received any notification that USAC had completed its review of the FCC Form 486.

Second, DSLA regularly queried the FCC Form 486 status through the submission of a query through the FRN Status Tool⁷. In each query file produced by the FRN Status Tool, the 486 Service Start Date field was blank, indicating that USAC's review of the FCC Form 486 was not yet complete.

Third, DSLA regularly checked the status of the FCC Form 486 via a query of Funding Year 2016 FCC Form 486 status through USAC's E-Rate Productivity Center ("EPC") online system⁸. In each query EPC reported a status of "In Review".

In late February, 2018, DSLA became concerned about what seemed to be an unusually long time for the processing of an FCC Form 486 submitted six months earlier, and (through its consultant) submitted inquiries to USAC.

On March 6, 2018, USAC for the first time notified DSLA of its decision to set the Service Start Date for each Funding Request to April 6, 2017⁹. USAC explicitly conceded that EPC reports an FCC Form

486 status of "In Review", even after USAC had processed the form. USAC furthermore explicitly conceded that its FRN Status Tool provided funding request records with blank Form 486 Service Start Date values, even after USAC had processed the form.

DSLAs submit instant request for review within 60 days of its first notification of USAC's decision to set the FCC Form 486 Service Start Date after the first day of the funding year.

Analysis

DSLAs submitted completed and certified FCC Form 486 No. 57577 on August 4, 2017, which was not later than 120 days after USAC's issue of a Revised Funding Commitment Letter. Furthermore, DSLAs submitted the FCC Form 486 within 120 days of the last day to receive service for each funding request cited in that form.

USAC erred in setting the Service Start Date after the first day of the funding year, in contravention of its own procedures for a case in which an RFCDL is issued, and in contravention of the Commission's directive in *Archdiocese of New Orleans*.

In several queries submitted to USAC's online automated systems on multiple dates over a long period of time, USAC's systems consistently reported that FCC Form 486 No. 57577 had not yet been processed. Even today, USAC's systems continue to report that USAC has not completed processing of this FCC Form 486¹⁰.

In compliance with the Commission's rules regarding appeals submitted to USAC, instant appeal is submitted within 60 days of USAC's notification to DSLAs of its decision to set Service Start Dates later than the first day of the funding year.

We also note that setting a delayed Service Start Date for the Funding Requests would impose severe hardship upon DSLAs, and the effect of such denial would be a profound adverse impact upon the educational services we provide for our students. The consequences of a denial of funding would not further the purposes of section 254(h) of the Telecommunications Act of 1996 or serve the public interest.

Relief requested

For the reasons stated in this letter, DSLAs respectfully requests that USAC set the Service Start Date for each Funding Request to July 1, 2016.
