Good evening Mrs.Sulhoff,

I hope you are doing well.

Earlier today, my colleague Robert Henson and I, left you a message in your voice mail. I am forwarding another important document for the record, which is a "**Fairness Opinion**", paid by Terrestar Corporation for a Telecommunication Valuation Opinion of the 1.4 GHz Spectrum License back in **February 4, 2008**. This study was so important, and what it truly did, was to enticed the general investing public in the purchase of Terrestar Corporation common stock, and what truly happen, many Terrestar Corporation minority common shareholders enter a carefully crafted, and massive bankruptcy scheme.

Unfortunately, four years later, in October 10, 2012, in the Terrestar Bankruptcy Confirmation Hearing in the (wrong venue), in the Southern District of New York, Terrestar so called financial adviser, testified under oath claiming the 1.4 GHz Spectrum License was only valued for a very low amount of **\$160,000,000.00 to \$235,000,000.00 Dollars**.

But Mrs.Sulhoff, in the Fairness Opinion study says something much different. The Wall Street brokerage firm, **Jefferies & Company**, clearly states, the 1.4 GHz Spectrum License being valued for the low end valuation **\$533,400,000.00 Dollars**, mid level value being **\$670,300,000.00 Dollars**, and the high end is for the amount of **\$856,200,000.00 Dollars**.

This can be review in detail in "**Page 20**" in the bottom in the middle of the page, or "7" of 14. Therefore Mrs.Sulhoff, once again, we need to question the intent, why would Terrestar Corporation Top Management, the Board of Directors, and its Lawyers would pay a Wall Street Jefferies & Company, back in **February 4, 2008** to complete a valuation opinion study, then four years later, the valuation of the 1.4 GHz Spectrum License is only valued prior, and during Terrestar proceedings, for only a low amount of **\$177,480,000.00 Dollars**. Another words, **\$360,000,000.00 to nearly \$680,000,000.00 Dollars less in valuation**.

We felt it was very important to share this additional information with you, and your department. We will post this in the "Comment", section in the Federal Communication Commission website as soon as possible.
