Dear Ms. Dortch:

In various submissions filed in this proceeding, CenturyLink, Inc. (“CenturyLink”) and Level 3 Communications, Inc. (“Level 3,” and together with CenturyLink, the “Applicants”) have reported the presence of fiber-based competitors both within and in proximity to overlap locations in CenturyLink’s ILEC region.<sup>1</sup> On September 8, 2017, the Applicants filed a letter in this docket reporting an anomaly in the data on which they relied to make these submissions and correcting it for certain competitor locations in the Tucson, Arizona, MSA.<sup>2</sup> The purpose of this submission is to report that this same anomaly had the effect of potentially overstating the presence of this same competitor in up to 99 locations in CenturyLink’s ILEC region outside of the Tucson MSA. After investigating the matter, the Applicants have determined that, for purposes of an overlap analysis, the data submitted previously for this competitor is unchanged for 70 of these locations<sup>3</sup> and requires material correction for 29 of these locations, though in one

location it turns out that the fiber-based competitor is present in the overlap location rather than within 0.25 mile of the location. More detailed information and corrections for these locations, including information about nearby fiber-based competitors for all of them, is set forth in the Highly Confidential attachment hereto [Bates Number CTLLVLT-000183].

The Applicants also take this opportunity to note that in identifying fiber-based competitors in the Highly Confidential attachment to this submission as well as the Highly Confidential attachment to the September 8th submission, the Applicants identified fiber-based competitors based on their lit buildings, not fiber route information.
