**Description of Network Changes Planned:**

**BellSouth Telecommunications LLC d/b/a AT&T Alabama**, is providing notice that copper facilities, SAI and Fiber to the Node (FTTN) architectural platform in the Springhill wire center **MOBLALSH** 4553 Old Shell Rd, Mobile, Alabama 36608 is being retired. This work is taking place in distribution areas DA 119401, DA 119501, DA 119601, and DA 119701 in the Springhill wire center due to an Alabama Department of Transportation road project. AT&T Alabama has deployed a Fiber to the Premises (FTTP)/Gigabit Passive Optical Network (GPON)/ platform serving the impacted addresses in the document embedded below. This action will require the retirement of copper distribution plant and service wires (Drops) in the network. This project will be completed on or after June 30, 2019.

**Description of Reasonably Foreseeable Impact of the Planned Changes:**

After the retirement of metallic feeder and distribution facilities, SAI, and FTTN facilities in the affected area, AT&T Alabama will: (1) no longer offer services over the FTTN facilities; and (2) cease maintaining the FTTN facilities. Retail and Resale POTS-grade service will be transferred from the current copper facilities to the new fiber fed GPON/FTTP Platform. Since the FTTN platform is a copper-based architecture, the copper distribution plant and copper service wires (Drops) will be replaced with new fiber service wires to the Network Interface Device (NID). There are presently 497 working services being migrated from the copper facilities to fiber under this notice. Currently there are 12 known CLEC circuits (9 - Local Wholesale Complete and 3 UNE-L circuits) that will be impacted by this project.
