Indianhead Telephone Company hereby provides notice that it intends to cease offering broadband internet transmission service as a separate component of its broadband internet access service. Effective November 1, 2019 Indianhead Telephone Company will only provide the transmission component as part of the complete broadband internet access service pursuant to the Federal Communications Commission's Wireline Broadband Order.¹ The geographic areas affected are Indianhead Telephone Company Study Area 330936.

Today, this service is provided to Indianhead Telephone Company's non regulated ISP. As stated in the attached customer notice, Indianhead Telephone Company will only provide the transmission component as part of the complete broadband internet access service (Private Carriage) effective November 1, 2019.
