



BREACH OF ETHICAL STANDARDS

Gratuities. I. BACKGROUND

Since 1997, Joeten-Kiyu Public Library has provided internet services to its library patrons first with 32Kbps Modem on a shared system, progressing to DSL and eventually adding to it, Wi-Fi accessibility, with this, a virtual network was established with the branch libraries of Tinian Public Library and Rota Public Library, to share and centralize it's library database and catalog system. With the introduction of the JKPL Bookmobile, the library services and internet accessibility has extended to the community in remote places of Saipan. The Library benefits through some discounts through the E-Rate which is a Federal Program that most service providers participate and utilize. This Proposal is for a new Internet and Telecommunications service that will provide and increase the services of the Libraries to provide the public with Internet and Library accessibility and opportunity.

II. SCOPE OF SERVICES

- ISP shall provide no less than the commercially business class internet connectivity at its highest available bandwidth
- ISP shall provide proof of redundancy of its services for telecom and internet.
- ISP shall provide bandwidth 24 hours per day, 365 days per year.
- ISP shall have network engineering support 24 hours per day, 365 days per year.
- ISP shall maintain network monitoring capability and notify JKPL at the point of any disruption of services at no time shall it take longer than 1 minute to send notification from the time the outage occurs.
- ISP shall provide web-based bandwidth utilization reporting
- ISP shall grant JKPL authoritative control over the services it receives.
- ISP shall install all services and equipment included in the proposal
- ISP shall guarantee quality of service minimum uptime 99% per month with minimum four (4) hours response and resolution to problems
- Network/Transit Delay shall not exceed an average of 80ms over a minute period where the circumstances are under the ISP's control.
- Packet loss shall not exceed an average of .5% over a 5-minute period where the circumstances are under the ISP's control.

General Terms

- I. **Contract Term.** The ISP Services Contract will begin at the time of installation and activation of all services and last for 1 year as required by E-Rate Guidelines for submission and reporting, with JKPL having an option to renew the contract for an added years.
- II. **Pricing.** Pricing Shall be quoted on a yearly contract initial term and include an option to extend for 30 days to meet procurement procedures in release of payment by the CNMI Government. Pricing shall be quoted as a monthly cost and will note potential discounts under E-rate or not. For the add-alternative option, pricing shall also be quoted as a monthly cost.
- III. **ELIGIBILITY AND DISQUALIFICATION OF BIDDER(S)**
 - a. **Initial eligibility of Bidder(s)**

Experience

Proposers must be able to demonstrate at least three (3) years of experience with at least three (3) entities that have a minimum of 8 concurrent connections and 200 unique users a day within one location. For each entity that the proposer has worked with, please provide their contact information as well as their number of concurrent connections and unique users a day.
 - b. **Outstanding Claims and Litigation**

Proposers are not eligible if at the time of submission the proposer, or any individual or entity of proposer, is in default, has any past due amounts or arrearages or is in breach of contract with any previous or existing contract with the CNMI. Further, the subcontract with whom the CNMI has any existing or pending litigation if the CNMI deems that such litigation may adversely affect the ability for the parties to effectively work together.
 - c. **Acknowledgement of Proposer**

Proposers shall thoroughly examine and become familiar with this ITB, including attachments, and any addendum that may be issued. The failure or the neglect of a proposer to receive or examine any ITB document shall in no way relieve it from any obligation with respect to its proposal or the obligations that flow from making a successful proposal. No claim based upon a lack of knowledge or understanding of any document or its contents shall be allowed.

d. Disqualification of Bid

Without in any way limiting the JKPL's right to reject any or all proposals, proposers are advised that any of the following may be considered as sufficient cause for the disqualification of a proposer and the rejection of a proposal: (i) failure to meet initial eligibility requirements;(ii)submission of more than one proposal by an individual, firm, partnership or corporation under the same or different names, including the names it does business under;(iii) evidence of collusion among proposers;(iv) improper communication with procurement and administering client.

Bids will be considered irregular and may be rejected for omission, alterations of form, additions not called for, conditions, limitation, unauthorized alternate proposals or other irregularities of any kind. All of the foregoing notwithstanding, however JKPL reserves the right to waive any such irregularities if permissible and within E-Rate recommended criteria.

VII. MISCELLANEOUS

a. Interpretation of the ITB

b. Consent to Investigate

The selection of the bidder will be based on a thorough investigation into the areas of interest expressed in the ITB. As part of that, the City may request the proposers to provide such things as, but not limited to, financial records, information on managing partners or participation in an interview process. By submitting a proposal, each proposer consents to any investigation the CNMI Govt. deems necessary.

c. JKPL's right to Cancel, Reject, Modify or Reissue ITB

The CNMI Govt with JKPL, in its sole discretion, reserves the right to modify, cancel, reissue or take any other action it deems necessary in the issuance of this RFP. Further, the CNMI Government. also reserves the right to reject any or all proposals submitted. Prior to the execution of the Concession Agreement, no action taken by the CNMI Govt. may be inferred or construed to give rise to any obligation by the CNMI Gov't.

d. Subcontracting

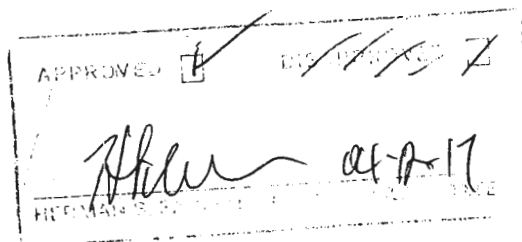

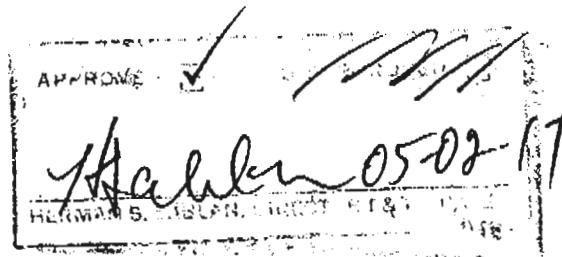

I. BACKGROUND

Since 1997, Joeten-Kiyu Public Library has provided internet services to its library patrons first with 32Kbps Modem on a shared system, progressing to DSL and eventually adding to it, Wi-Fi accessibility, with this, a virtual network was established with the branch libraries of Tinian Public Library and Rota Public Library, to share and centralize it's library database and catalog system.
