

The Bienville Parish School District, BEN # **139293**, 471 application #'s 191009938, 191040829 & 191007662 is appealing the decision by USAC to deny our funding requests due to being in a red light status. Due to program rules USAC was prohibited from reviewing our original appeal because payment was made after the notice of dismissal. We are requesting the FCC grant this appeal review based on the attachments that we have included.

We received a notice of withholding of action dated April 2, 2019, (Attachment 1), which stated that payment had to be made within 30 days. Payment was made by check on April 23, 2019, (Attachment 2). We were not aware that paper checks were not acceptable. On a letter dated May 15, 2019 we received a notice of dismissal stating that no funding will be provided or the appeals will not be reviewed, (Attachment 3), due to lack of satisfying our debt. After investigation we realized that paper checks were not accepted and we immediately submitted payment electronically to satisfy the debt on May 30, 2019, (Attachment 4).
