Pursuant to Commission Rules 51.325 – 51.335, CenturyLink hereby submits for Qwest Corporation the attached Public Notice No. 816 for copper retirements associated with wire centers in Forest Lake and Park Row, Minnesota. Copper retirements are necessary to respond to various factors, including in these contexts, road moves requiring adjustments in Outside Plant.
