REPLY COMMENTS

Julian Jetzer d/b/a Sheboygan Falls Broadcasting ("SFB") hereby submits reply comments in support of its counterproposal in this docket. SFB's counterproposal requests the allotment of Channel 294A to Sheboygan Falls, Wisconsin instead of the allotment of 294C3 to Allouez, Wisconsin, which was proposed by Michael R. Walton. As shown in SFB's counterproposal, the allotment of Channel 294A to Sheboygan Falls would comply with all spacing requirements and would provide Sheboygan Falls with its first local broadcast service. SFB's proposal constitutes a higher level allotment priority than that of Michael R. Walton.


