Apologies for the delayed response. I'm in the processing of applying erate discount to FRN 1799066177, but we're unable to process due to discrepancies between the connection speed (200Mbps) provided on form 471 and billing information (20Mbps, 100Mbps and 200Mbps). Connection speed on form 471 must align with billing information before discount can be applied. That said, form 471 will need to be updated to include speeds of 20Mbps and 100Mbps, but since LDI is 2/26/19, it will be best if you opt for BEAR method of funding.
