Unicom Communications, LLC (FRN: 0014-99-4602) (referred to herein as “Unicom”) hereby applies for authority pursuant to Section 63.71 of the Federal Communications Commission’s (Commission) rules, 47 C.F.R. § 63.71, and Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, to discontinue its local and long distance telephone service throughout Unicom’s territory.

### 3. Points of geographic areas of service affected

Unicom seeks authority to discontinue the provision of local and long distance telephone services in Florida and North Carolina.

**4. Brief description of the type of services affected**

Unicom provides local and long distance telephone services. Unicom currently has approximately 125 customers purchasing local and long distance telephone services. Current customers have the option of moving to alternative service providers, such as Frontier Communications of the Carolinas, LLC, AT&T Corp. & Windstream Communications, Inc.. Customers can also turn to numerous other providers of similar services.

**5. Brief description of the dates and methods of notice to all affected customers**

Unicom notified its local and long distance telephone service customers of the planned discontinuance by letter sent via U.S. Mail on November 5, 2018. Those customers were told that the proposed discontinuance would take effect on December 20, 2018, or as soon after that date as authorized by the relevant regulatory commissions.

**6. Dominance of carrier with respect to the service to be discontinued**


Unicom is not a dominant carrier with regard to the services to be discontinued.

**Re: Notice of Discontinuance of Service**

**YOU MUST CHOOSE A NEW TELEPHONE SERVICE PROVIDER BY [30 DAYS PRIOR TO THE PROPOSED DISCONTINUANCE OF SERVICE DATE] TO AVOID A POSSIBLE DISCONTINUATION OF SERVICE**

Dear Customer,

We regret to inform you that – subject to the approval of the North Carolina Public Utilities Commission (NCUC) and the Federal Communications Commission (FCC) – Unicom Communications, LLC, 17 Smoky Mountain Drive, Franklin, North Carolina 28734 will no longer be providing your local or long telephone service effective December 20, 2018. The discontinuance of service by Unicom Communications, LLC is necessary due to insurmountable financial difficulties. The discontinuance of service will be in Unicom Communications, LLC's service area; throughout North Carolina and Florida.

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. Address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington DC 20554 and include in your comments a reference to the §63.71 Application of Unicom Communications, LLC. Comments should include specific information about the impact of this proposed discontinuance on you or your company, including any inability to acquire reasonable substitute service.

Your action is required! You must select a new local and long distance telephone provider as quickly as possible but no later than [30 days prior to the proposed discontinuance of service date]. If you do not select a new local and long distance telephone provider on or before [30 days prior to discontinuance of service date], the NCUC may require that you be assigned to another carrier.

Please be aware that you remain responsible for paying all bills rendered to you by Unicom Communications, LLC during this transition. You may be subject to suspension or termination of your phone service in accordance with NCUC rules if you fail to pay your telephone bill.

After selecting a new local telephone provider, you should also contact your current long distance provider to ensure that your current long distance calling plan is not changed as a result of your change in your local service. If you do not contact your long distance provider, you may be charged basic rates (non-calling plan rates) for long distance calls.
