Uniti Group Inc. is the corporate parent of the following licensed telecommunications subsidiary companies (including Southern Light, LLC). Besides the companies listed below, neither Uniti Group Inc. nor Southern Light hold any interests in, or is “affiliated” (as defined in 47 U.S.C. § 153(2)) with any other telecommunications service provider.

Competitive Categorization:

In all cases, each subsidiary listed below is licensed in the states listed as a competitive service provider. No subsidiary within the Uniti Group Inc. group of companies is classified as an incumbent provider in any location.

Southern Light, LLC

State of Formation: Alabama

Description of Services: Southern Light is a facilities-based provider of competitive data and voice services to customers. It provides services primarily to business, government, health care, and educational customers. It also provides services to other carriers.

States Licensed to Provide Telecommunications Services: Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Pennsylvania.

Uniti Fiber LLC

State of Formation: Delaware

Description of Services: Uniti Fiber is a facilities-based provider of competitive data and voice services to customers. It primarily provides services to other carriers, including backhaul services for large wireless CMRS providers. It also provides services to business, government, health care, and educational customers. It is the parent company of the PEG Bandwidth Subsidiaries and Contact Network noted below.

States Licensed to Provide Telecommunications Services: Alabama, California, Florida, Michigan, North Carolina, Ohio, South Carolina, Texas, and Wisconsin. Uniti Fiber LLC currently has an application pending before the Arkansas Public Service Commission.

PEG Bandwidth Subsidiaries

States of Formation: All of the below-listed subsidiaries are formed under the laws of Delaware with the exception of PEG Bandwidth NY Telephone Corp., which is formed under the laws of New York.

Description of Services: The PEG Bandwidth Subsidiaries are facilities-based providers of competitive data and voice services to customers. They primarily provide services to other carriers, including backhaul services for large wireless CMRS providers in the states in which they are licensed. They also provide competitive telecommunications services to business, government, health care, and educational customers. (In recent years, Uniti Fiber LLC has sought its own licenses to provide service to its customers rather than utilizing the state-by-state licensees noted below).
