Re: Letter of Appeal of Funding Commitment Decision Letter for funding Year 2018, issued 05/04/2018.

Dear Sir or Madam:

I am submitting this letter of appeal regarding E-rate FY 2018 funding request for Internet Access, on the grounds that, a ministerial/clerical error occurred. The service was selected after the required Form 470 28-day bidding window and prior to certification of the Form 471 per USAC requirements but the FRN was accidentally omitted during data entry of the Form 471.

The issue in this case boils down simply to this: The missing funding was based on an administrative error as it was omitted by mistake prior to certification of the Form 471. The 2018 Form 470 for internet services was certified on 12/18/17 and the minimum 28-day bidding window closed on 01/15/18. Cogent was selected to provide 200mbps to 303 Haverhill Street and the proposal was signed 02/20/18. The signed quote from Cogent has been included. The Form 471 was certified on 03/01/2018 without this new service added. This falls under the category of a ministerial/clerical error. Based on the Bishop Perry Order, we request USAC actions remain consistent with this order and FRN for Cogent **in the amount of \$1,500 MRC** be funded on the 2018 application.

Given that the denial of funding in this case was based on merely an administrative error, regarding accidental omission of a new service, the Parties respectfully request that the SLD process this Letter of Appeal and approve the funding for Notre Dame Cristo Rey High School. The denial of funding for an administrative error places a particular hardship on a school district such as Notre Dame Cristo Rey High School that otherwise should have been approved for and received E-rate funding for its application.

We respectfully request that you process this appeal and add the funding request to the 2018 application. The required FRN information is attached. Thank you for reviewing this appeal. Please use the contact information below.
