During the meetings, VON discussed positions consistent with its comments filed in the above-referenced dockets. Specifically, VON reiterated its support for elimination of rural call completion reports, its opposition to application of cramming regulations to providers of interconnected VoIP, its position that the Commission should maintain the

deadlines for the transition to bill-and-keep for intercarrier compensation, and its concern that new robocall regulations not result in the blocking of legal calls or hinder the development of new technologies and services that may use telephone numbers in ways that are different than traditional wireline or wireless carriers.
