Moniteau School District is respectfully requesting a Waiver for Extension of filing due date for 2018 Funding Year Form 472 BEAR Form.

This request is necessitated due to USAC action to deny/suspend processing of timely filed BEAR Form 472 and Billed Entities desire to secure reimbursement for associated approved funding.

Circumstances regarding this issue are as follows.

Moniteau School District is a public school district in the state of Pennsylvania

Moniteau School District submitted an FCC 472 BEAR form for the 2018 funding year (7/1/2018-6/30/2019) on 10/11/2019 (see attached BEAR Form 472 – C-1 to C-3). This form was submitted prior to the 2018 funding filing due date of 10/28/20019.

USAC has denied requested funding in its entirety citing the explanation "You did not respond to the invoice reviewer's request(s)" (reference attached USAC letter 11/1/2019 – B-1 to B-3)

According to USAC (phone inquiry 11/4/19 – Case #288883 – summary attached), the assigned Form 472 reviewers inquiry notification was sent to the email associated with Moniteau School District PIN number (john#204) issued 10/9/2005. The associated email address jdamore@moniteau.k12.pa.us was decommissioned 11/2017. No other attempts by USAC to contact the Billed Entity have been documented and the Billed Entity is in fact asserting that they were unaware and not notified that there was any issues with the timely filed form 472. Therefore the Billed Entity was not afforded an opportunity to respond to the Reviewers inquiry regarding the timely filed 472 BEAR Form.

The Billed Entity to date has not been made aware as to what the Form 472 review inquiry issue may have been (or is), but can only assume that it would be easily resolved considering the reimbursement being requested is for basic internet service at the Billed Entities 2 public school buildings.

Apparently, no other means of communication were attempted by the Reviewer to request response to their inquiry. USAC did by inclusion on the timely filed form 472, have access to the Billed Entities phone number 724-637-2117 ext 2850. USAC also had access to the Billed Entities address, 1810 West Sunbury Rd, West Sunbury PA.. USAC also had access to the Billed Entities current contact email address jdamore@moniteau.org. **(Please note "Preferred Mode of Contact" on attached B-1)**

The Billed Entity inquired to its Technology Director who concurred that it would be likely that any communication to the decommissioned email address would have prompted a response to the sender (USAC Reviewer) that the email address did not exist. If this was the case, it would be considerate for the Reviewer to attempt other readily available means to contact the Billed Entity.

The **E-File Applicant Terms and Conditions (attached - F-1)**, located at slweb.usac.org/Bear/beterms.aspx, relating to PIN usage makes no indication that the sole means of communicating follow up Reviewer inquiries with the applicant will be limited to the email address associated with the originally filed PIN application. In fact the Terms and Condition section states "at the contact information provided on the forms", which in this case included a contacts for phone number and mailing address.

RESULTS

USAC has informed the Billed Entity (Moniteau School District) the timely filed 472 BEAR Form cannot be re-cued into the review process and **the only solution is to re-submit a new BEAR Form** for Funding Year 2018 – (see **Case Inquiry #288883 11/4/19 attached – A-1 to A-2**).

The Billed Entity first became aware of this issue subsequent to the filing/extension filing due date of 10/28/2019 when the Billed Entity was notified of the issue via United States Postal Service by USAC letter dated 11/1/2019.

Since the filing due date for 2018 BEAR Forms has passed, **the solution suggested by USAC will not be possible unless a Waiver of the Filing Due Date** in this circumstance is granted to the Billed Entity.

The Billed Entity asserts that no willful neglect of filing due dates, nor attempt to disregard a known request for additional supporting documentation exists in this instance and it is for this reason that the Moniteau School District (Billed Entity) respectfully requests consideration for an Extension to File BEAR Form 472 for Funding Year 2018 applicable to Funding Commitment # 181030001.

Per our conversation your invoice was denied due to no response from applicant. You would need to update a new pin template request with your updated email address and submit it for a new pin. Also you would have to submit an appeal to the FCC to ask for more time to submit your invoice. Parties that are seeking a waiver of FCC rules or that have filed an appeal with USAC and received a decision may, if they choose, appeal USAC's decision to the FCC. You must submit your appeal to the FCC within 60 days of the date when USAC issued the decision.

On all communications with the FCC, be sure to reference the Docket No. 02-6.

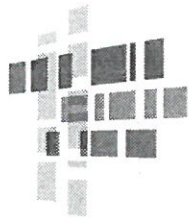

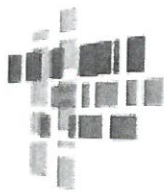

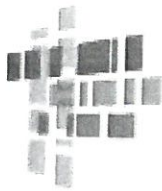
