Dear Ms. Dortch:

Pursuant to Section 64.1120(e) of the Commission's rules, 47 C.F.R. § 64.1120(e), NTC International, Inc. ("NTC"), by its counsel, respectfully notifies the Commission that NTC intends to acquire the customer base of its affiliate, NobelTel, LLC ("Nobel").¹ NTC is complying with the Commission's rules and procedures governing compliance with Section 258 of the Communications Act of 1934, as amended, including the provision of advance written notice to all affected customers. In conformity with Commission rules, NTC provides the following information:

Parties to the Transaction: The parties involved in the transaction are NobelTel, LLC (the Assignor) and NTC International, Inc. (the Assignee).

Types of Telecommunications Services Provided to the Affected Subscribers: NobelTel provides prepaid and postpaid "dial-around" or "PIN-free" long distance telephone services to the affected subscribers on a retail basis.² NTC will provide the same services to these subscribers.

¹ NTC and NobelTel are commonly-owned affiliates. The customer transfer discussed herein is being implemented as part of an internal reorganization of the affiliated companies.

IMPORTANT NOTICE REGARDING YOUR NOBELTALK LONG DISTANCE TELEPHONE SERVICE

Dear NobelTalk Customer:

We're very pleased to let you know that, in order to improve the quality of your long distance experience, NobelTel, LLC (NobelTel) is reorganizing its operations. All of NobelTel's telecom services, including your NobelTalk dialaround telephone service,¹ will be provided through a newly formed affiliate, NTC International, Inc. (NTC). NTC is owned and managed by the same team of professionals that currently provide your NobelTalk telephone service and you will continue to receive the same high-quality service from NTC.

- **No action on your part is required.** You always have the right to choose another carrier for your long distance telephone service, but we hope that you'll continue as an NTC customer and we look forward to the opportunity to continue providing you with quality telephone services. You will not incur any fees in connection with this transfer of your service.
- **Your dial-around telephone services will not be affected.** You'll continue to use the same access telephone numbers and the same PIN. As an NTC customer, you'll continue to receive the same services at the same rates, terms and conditions as you currently receive. As always, notice of any future changes in rates, terms and conditions of service will be provided to you as required by law.
- **The effective date of the transfer will be on or shortly after December 10.** At that time, unless you have made alternative arrangements, NTC will become your service provider for dial-around long distance services.² If you prefer to choose a telephone provider other than NTC for these services, you are free to do so and to discontinue your subscription to NTC's services at any time.

Our customer service operations will continue to provide the same level of quality support for your telephone service needs following the transfer to NTC.
