### **Description of Network Changes Planned:**

Wisconsin Bell, Inc. d/b/a AT&T Wisconsin, is providing notice that copper facilities, SAI and Fiber to the Node (FTTN) architectural platform in the Madison Pflaum wire center **MDSNW114** at 805 Pflaum Rd Madison, WI 53716 is being retired. This work is taking place in distribution areas DA 2125 in the Madison Pflaum wire center due to Wisconsin Department of Transportation road project #5992-09-41/42/42. AT&T Wisconsin has deployed a Gigabit Passive Optical Network (GPON)/Fiber to the Premises (FTTP) platform serving the addresses in the embedded document below. This action will require the retirement of copper distribution plant and service wires (Drops) in the network.

### **Description of Reasonably Foreseeable Impact of the Planned Changes:**

After the retirement of metallic feeder and distribution facilities, SAI, and FTTN facilities in the affected area, AT&T Wisconsin will: (1) no longer offer services over the Copper and FTTN facilities; and (2) cease maintaining the Copper and FTTN facilities. Retail and Resale POTS-grade service will be transferred from the current copper facilities to the new fiber fed GPON/FTTP Platform. Since the FTTN platform is a copper-based architecture, the copper distribution plant and copper service wire (Drops) will be replaced with new fiber service wires to NID. There are presently 71 working services on the copper facilities being retired under this notice. Currently there are 10 Wholesale circuits that will be displaced or disrupted on this project.
