

Grant of the requested authority will permit approval of a series of transactions whereby the ownership of Great Wireless, the holding company for US Connect, will be transferred from Suleman Bhimani to Gabrysiak and Porter USA, and from Gabrysiak to Porter USA. As a result of these transactions the ownership of US Connect's corporate parent will change necessitating the need for this filing. The proposed transfers will benefit the public interest, and will allow US Connect to expand its business. In accordance with 47 C.F.R. § 63.03, the parties request streamlined processing of this Application.

- (7) US Connect is a non-dominant carrier that is authorized to resell eligible telecommunications carrier services from various facilities based carriers. US Connect is authorized by the FCC to offer domestic interstate services in US as a non-dominant carrier.

Great Wireless is a holding company and is not authorized to directly provide telecommunications services.
- (8) This Application is appropriate for streamlined treatment based on Section 63.03(b)(1)(I) and 63.03(b)(2)(I).
- (9) US Connect did not obtain a Section 214 International authorization.

Consummation of the proposed transaction will result in net benefits to US Connect's customers by strengthening its financial status. The transaction will enhance US Connect's ability to offer a broader range of innovative products and services to customers.

In summary, consent to the proposed transaction will allow US Connect to continue providing quality service to a greater number of customers and will increase competition.

In view of the foregoing, the applicants respectfully request that the Commission consent to the transfer of control of the ownership of Great Wireless, LLC and its wholly-owned subsidiary US Connect, from Great Wireless, LLC, Suleman Bhimani, Owner to Great Wireless, LLC, Patricia Gabrysiak, an individual and Porter USA Enterprises, Inc., Owners and from Great Wireless, LLC, Patricia Gabrysiak, Majority Owner to Great Wireless, LLC, Porter USA Enterprises, Inc.

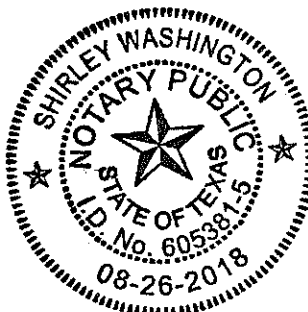

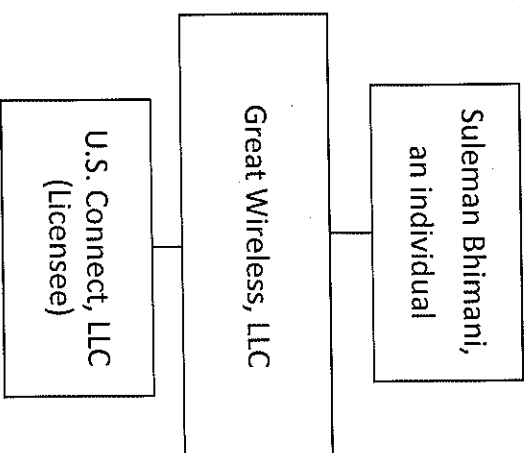

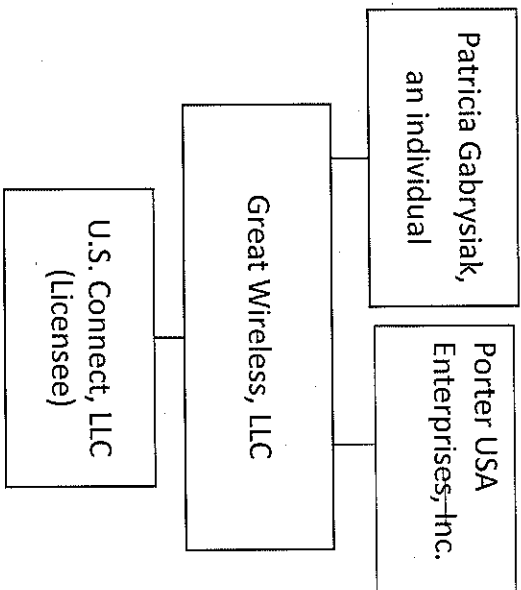

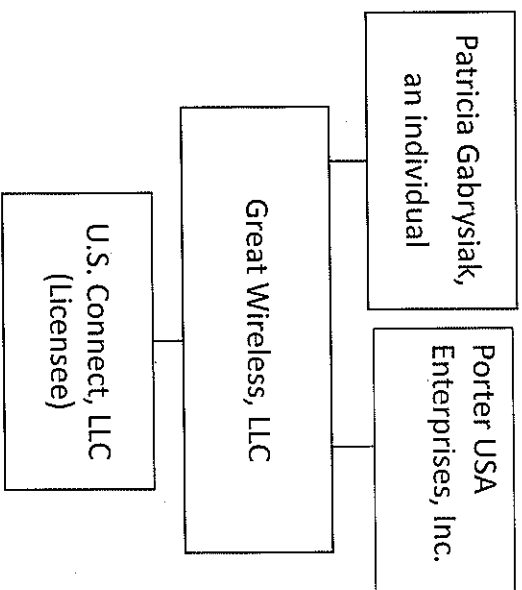
Pre-Transaction Org Chart
