Planned Implementation or Retirement Date: Will not be implemented for 90 days after the release of the Commission's public notice of filing.

Description of Change:

Replace copper (metallic) feeder facilities with fiber optic cable and Digital Loop Carrier (DLC) systems. The public notice of this network change will identify the services that will be transferred to the DLC. Changes may occur to existing circuits because they are not compatible with DLC. Any existing UNE xDSL or Digital Design Loop (DDL) services may be disconnected with this network change.

Description of Foreseeable Impact:

After the planned network changes are implemented, there will be no copper (metallic) loop facilities between Consolidated Central Office and the remote terminal in the affected area. Copper (metallic) sub-loop facilities will remain in place between Consolidated's Remote Terminal and customer premises in the affected area.

The following loop types will be transferred to the new DLC systems:

2-Wire Analog Voice Grade Loop except those circuits identified below as Services impacted.

The following UNE loop types plus any services not specifically identified that require copper cable for provisioning will no longer be available from Consolidated's identified above Central Office's to customer premises in the affected area:

2-Wire ADSL - Compatible Loop (ARDU)	2-Wire HDSL - Compatible Loop
4-Wire HDSL - Compatible Loop	2-Wire IDSL - Compatible Metallic Loop (ISDN)
2-Wire SDSL - Compatible Loop (HDSL-2)	2-Wire Digital Designed Metallic Loop (DDS 2)

Description of Changes to Rates, Terms & Conditions: There will be no change to the Rates, Terms or Conditions for Telecommunications Services.
