Notice of any future changes in rates, terms, and conditions of service will be provided to you as required by law. Service will continue without interruption. You will incur no carrier change charges as a result of this transaction.



Please note that if you are currently a Company customer and have placed a "freeze" on your long distance service to prevent unauthorized transfer to another carrier, it will automatically be lifted to implement the transfer to LHLD. At your request, freeze protection can be reestablished after the transfer.

Please also note that LHLD will be responsible for addressing any complaints you may have regarding services provided by it on or about January 1, 2020, as well as complaints that arise prior to that date with respect to services provided by the Company.
