To whom it may concern:

We hereby appeal USAC's FCDL's regarding FRNs 1899015963, 1899082148, 1899082141, 1899082183, and we note a related issue in pending FRN 1899081973. These FRNs resulted in significantly different eligibility percentages for the SAME device - SonicWALL NSA 2650 FW, with the SAME SKU number - 01-SSC-1936.


In response to various of the above FCDLs, consultant for all these applicants opened a Customer Service Case (Case Number 240998) and, on October 31, 2018, USAC's response in the Customer Service Case "highly recommend[ed] filing an appeal for all of the variations."

For BEN 63565, the Firewall was reduced by 50%. For BEN 10307 the same Firewall was funded without reduction. For BEN 10854, the same Firewall was reduced by 40%. For BEN 11103, the same Firewall was funded without reduction.

We did not determine the need for an appeal until we received multiple FCDLs with multiple reduction percentages for this Firewall and, in response to the above USAC Customer Service Case, USAC responded on October 31, 2018, with advice to appeal all these determinations. Therefore, we ask for a waiver of the appeal filing deadline in light of these circumstances.

In light of the significant inconsistency by USAC in each of the FRNs above, USAC should allow the full requested funding amount for each FRN set forth above. Thank you for your consideration of this matter. Please let us know if you require any additional documentation or materials.
