Grand Mound Cooperative Telephone Association hereby provides notice that it intends to cease offering broadband internet transmission service as a separate component of its broadband internet access service. Effective January 1, 2020 Grand Mound Cooperative Telephone Association will only provide the transmission component as part of the complete broadband internet access service pursuant to the Federal Communications Commission's Wireline Broadband Order.¹ The geographic areas affected are Grand Mound Cooperative Telephone Association Study Area 351191.

Today, this service is provided to Grand Mound Cooperative Telephone Association's non regulated ISP. As stated in the attached customer notice, Grand Mound Cooperative Telephone Association will only provide the transmission component as part of the complete broadband internet access service (Private Carriage) effective January 1, 2020.
