Submission for the Record of Joe Shields on The Yodel  
Technologies LLC Petition For Expedited Declaratory Ruling  
on Soundboard Technology

I am providing the Commission with an updated list of transcripts of illegal soundboard/avatar robocalls my family and I have received. Notably, the petitioner and commentor's that support creating an exemption for these soundboard/avatar robocalls have not submitted a single transcript of their alleged "legal" robocalls. That fact indicates clearly that the soundboard/avatar robocalls are not introduced by a live person asking for permission to playback recording snippets.

The Commission should note that the majority of these robocalls was received after the Northstar petition was filed with the Commission.
