## **FCC ANNOUNCES THE CHAIR, VICE CHAIR AND MEMBERSHIP OF THE NORTH AMERICAN NUMBERING COUNCIL**

This Public Notice serves as notice that, consistent with the Federal Advisory Committee Act,<sup>1</sup> Federal Communications Commission (FCC or Commission) Chairman Ajit Pai has appointed members to serve on the North American Numbering Council (NANC).

Chairman Pai has designated the Honorable Travis Kavulla, Commissioner, Montana Public Service Commission, to serve as Chair of the NANC, and Diane Griffin Holland, Vice President, Law and Policy, USTelecom, to serve as Vice Chair. A full list of NANC members is attached to this Public Notice.

In addition to participation by NANC members on the Working Groups, the Commission also welcomes participation by parties that are not NANC members but have an interest in specific issues in a working group.
