Supplemental Response

This is a Supplemental Response to the Darryl B. Beauford Petition to Deny the Transfer of Control of the Broadcast License of WSB-TV to Terrier Media Buyer, Inc. **WSB-TV clearly violated FCC CFR §73.3526 Public Inspection File.** This was positively validated when Agent Alethia Nicholson of the FCC's Enforcement Bureau Field Office formerly located in Duluth, Georgia visited WSB-TV after I filed my complaint #722407.

WSB-TV is a Violator of FCC Rules and Regulations. By granting the approval of the Transfer of Control of WSB-TV's Broadcast License to Terrier Media Buyer, Inc., the Commission would be granting Cox Enterprises a Privilege of profiting \$3.1 Billion.

The Federal Communications Commission does not grant Privileges to Rules and Regulations Violators. As Agent Alethia Nicholson can attest, WSB-TV clearly violated FCC CFR §73.3526 Public Inspection File.

Conclusion

I ask the FCC not to approve the Transfer of Control of Cox Enterprises/Cox Media Group/Georgia Television, LLC/WSB-TV's Broadcast License. When I visited WSB-TV to view the Public Inspection File, I was not granted access to it. A "Post-It" was handed to me with FCC.GOV on it. There was no procedure in place to view the file, no one asked me for identification to prove I am a viewer of the Community. Proof of this is Tim McVay was told someone came to view the file and did not see it. This is what he admitted to me when he and I had our telephone conversation in October 2015 before my ordered second visit to WSB-TV. What I really find appalling, is when I buzzed the front door of WSB-TV and told the security guard the reason for my visit, **she would not allow me to enter the building.**




