

Please amend my above-referenced application to include the attached materials.

Specifically, this amendment reports applications now pending before the FCC. Additionally, this amendment reports the ownership interest of my father, John R. Powley, in Station WIIM-TV, Iron Mountain, Michigan.

I have been advised by counsel that I incorrectly misread question 8(b) of Section II of the application form with respect to the media interest of immediate family members. It was my understanding that the question sought to elicit information on any reportable media interests in the same area as Slidell, and based on that understanding, my response is true. However, I have been advised that my reading of that question was not correct. By this amendment, his interest in WIIM-TV is hereby reported. It should be noted that Iron Mountain, Michigan is not in the same area as Slidell, Louisiana.

As a result of reviewing my application in this context, I discovered that I inadvertently omitted reference to two broadcast applications now pending for Manistee, Michigan, and Centerville, Texas. Therefore, this amendment contains that information.
